The purpose of the bid, opened on January 8, 2002, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of auto-body repairs for heavy-duty trucks, vans and buses, for the Department of Transportation, Vehicle Maintenance. The terms of agreement, as contained in the contract, awarded by the Board on February 13, 2002, provided that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to extend for the first one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of October 2002, indicated an increase of 2.0%.
