The purpose of this bid, opened on December 2, 2004, is to purchase, at firm unit prices, quantities, as may be required, of carbonated beverages, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 49 vendors sent bid forms or card notices of this advertised bid, 4 responded, with 2 regular bids and 2 no bids.

Coca-Cola Enterprises, d.b.a. Florida Coca-Cola Bottling Company, was the only vendor to submit a bid on Group I — Coca-Cola Products, Items 1A through 1G. The prices submitted on this bid are considered excessive under current market conditions. Pursuant to Department of Education Rule 6A- 1.012(8) — Purchasing Policies, when the School Board finds that no valid or acceptable firm bid has been received within the prescribed time, the Board may enter into negotiations with a supplier of such goods or services, and shall have the authority to execute contracts with said suppliers of such goods and services, under whatever terms and conditions as the Board determines to be in the best interest of the school system.

Staff discussed with Coca-Cola Enterprises, d.b.a. Florida Coca-Cola Bottling Company, the only vendor bidding on Group I - Coca-Cola Products, Items 1A through 1G, the possibility of lowering its bid price to be consistent with current market conditions. The initial bid price received was \$5.93 per case of Coca-Cola products, which was reduced to \$5.73 per case of Coca-Cola products, reflecting a potential savings of \$36,000.

No bids were received for Item 3A. The recommendation reflects that this item be rejected. Competitive prices will be solicited for this item, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
