SUBJECT: PARTIAL AWARD BID NO. 001-DD08 – PHYSICAL EDUCATION SUPPLIES

The purpose of this bid, opened on October 21, 2003, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of physical education supplies, for Stores and Mail Distribution stock.
