The purpose of the bid, opened on February 1, 2001, was to establish a contract. to purchase, at firm unit prices, quantities, as may be required, of classroom supplies, for Stores and Mail Distribution stock. The terms of agreement, as contained in the contract, awarded by the Board on April 18, 2001, and extended on April 17, 2002, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardees have agreed to extend for the second one (1) year extension period, by letter, on file, with the exception of AFP Industries, Inc., of Miami, Florida, who did not wish to extend their prices and Pyramid School Products, of Tampa, Florida, who did not wish to extend their prices for item 12 on the contract. Competitive prices will be solicited for this item as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure. It is considered to be in the best interest of the Board to extend this contract, for an additional (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of December 2002, indicated an increase of 2.4%.
