The purpose of the bid, opened on March 22, 2001, was to establish a contract, to purchase, at firm unit prices, services, as may be required, of armed and unarmed security guards, for various locations. The terms of agreement, as contained in the contract, awarded by the Board on April 18, 2001, and extended on May 15, 2002, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardees have agreed to extend for the second year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period. The vendors have requested an increase in pricing at the current Consumer Price Index (CPI). The February 2003 CPI was 3.0%.

The extension reflects an increase in the hourly rate, based on the current CPI, and as allowed for in the terms and conditions of the bid. However, the extension hourly rate is lower than the rate of other governmental agencies.
