The purpose of this bid, opened on February 11, 2003, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of vacuum cleaners, for various schools and departments. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. This bid is a Minority/Women Business Enterprise (M/WBE) set-side for African American/Women-owned and operated businesses. Of 20 vendors sent bid forms or card notices of this advertised bid, 6 responded, with 5 bids meeting specifications (not all vendors bid all items) and 1 non-responsive bid (vendor is not minority certified).

Inasmuch as the specifications for Item 5 - Vacuum cleaner, were unclear, the recommendation reflects that all bids be rejected. Competitive prices will be solicited for this item, as the need arises, pursuant to Board Rule 6Gx13-3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Items 6 and 8 were awarded by the Board on May 14, 2003, for an estimated expenditure amount of \$48,663.56.
