The purpose of the bid, opened on January 30, 2001, was to establish a contract. to purchase, at firm unit prices, quantities, as may be required, of water-treatment chemicals and supplies, for Maintenance Materials Management stock. The terms of agreement, as contained in the contract, awarded by the Board on April 18, 2001, and extended on June 19, 2002, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardees have agreed to extend for the final one (1) year extension period, by letter, on file, with the exception of Southern Water Consultants, of Decatur, Alabama, for Item 3 -Algaecide. Competitive prices will be solicited for this item, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of March 2003, indicated an increase of 3.0%.
