SUBJECT: AWARD BALANCE BID NO. 001-DD08 – PHYSICAL EDUCATION SUPPLIES

The purpose of this bid, opened on October 21, 2003, is to establish a contract, at firm unit prices, quantities, as may be required, of physical education supplies, for Stores and Mail Distribution stock. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 49 vendors sent bid forms or card notices of this advertised bid, 16 responded, with 13 regular bids, 1 non-responsive bid and 2 no bids.
