SUBJECT: PARTIAL AWARD BID NO. 103-EE02 -- FOOD-SERVICE EQUIPMENT

COMMITTEE: INNOVATION, EFFICIENCY & GOVERNMENTAL RELATIONS

The purpose of this bid, opened on January 19, 2006, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of various food-service equipment, delivered for use in the Food Service Program of the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 45 vendors sent bid forms or card notices of this advertised bid, 5 responded, with 2 bids meeting specifications, 1 bid not meeting specifications and 2 no bids.

Items 1 through 9, and 14, for alternate awardee and Items 12, 13, 23 and 24 are being held for further evaluation.

Inasmuch as all bids received for Items LE, LP, and LG - Hourly labor rates for non-standard installation, are considered excessive under current market conditions, the recommendation reflects that these items be rejected. Competitive prices will be solicited for these items, as the need arises pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Benchmarking was completed against The School Board of Palm Beach County, Florida, and the District's prices were found to be lower.
