The purpose of this bid, opened on May 6, 2004, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of estimated requirements for armed and unarmed security guards, for various schools and departments. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 100 vendors sent bid forms or card notices of this advertised bid, 23 responded, with 9 regular bids and 14 non-responsive bids.

Staff prepared an agenda item for the June 16, 2004, Board meeting, which was withdrawn on June 10, 2004, in order to resolve three protests from vendors not recommended for award as the primary vendors.

The Senior Assistant School Board Attorney and Procurement staff met with each vendor to discuss the merits of the individual protest.

- Trinity Security was deemed non-responsive due to its failure to meet the minimum eligibility hours. The company was unable to provide sufficient documentation to change the original assessment of non-responsiveness.
- Pentagon Security was deemed non-responsive. A principal in Pentagon Security was also a principal in Pentagon Healthcare Services. This company was defaulted by the School Board for non-performance and failed to seek reinstatement as a responsible vendor. Documentation of the decision rendered by the Contractor Responsibility Committee was provided to the vendor, as well as the Board item terminating the contract and imposing the default provisions.
- Corporate Protection Security protested the financial stability of another vendor,
 Central Security. This protest concerned a performance issue, not a responsiveness issue, and Corporate Protection Security was so advised.
