SUBJECT: AWARD BID NO. 110-DD09 – LAMPS AND BULBS

COMMITTEE: BUSINESS AND FINANCIAL SERVICES

The purpose of this bid, opened on September 28, 2004, is to purchase lamps and bulbs, for Maintenance Materials Management stock and Stores and Mail Distribution stock, at firm unit prices or discounts. This is a term bid which states that the Board may purchase quantities, as may be required, but is not obligated to purchase any guaranteed amount. Of 61 vendors sent bid forms or card notices of this advertised bid, 15 responded, with 12 bids meeting specifications and 3 no bids.

Item 28 - Lamp, HPS, 70 watts, medium base, is being rejected, inasmuch as it is a duplicate of the product being awarded for Item 38, at a lower price. This recommendation reflects that all bids received for this item be rejected.

This bid reflects an estimated savings of \$32,573.27, based on current bid prices.
