SUBJECT: AWARD BID NO. 099-GG06 – SPRINKLERS, LAWN AND TURF

STRATEGIC PLAN: IMPROVE CONSTRUCTION AND MAINTENANCE SERVICES**

The purpose of this bid, opened on October 9, 2007, is to purchase, at firm unit prices, quantities, as may be required, of lawn and turf sprinklers, for Maintenance Materials Management stock. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Four (4) vendors responded to the advertised solicitation.

Inasmuch as the model number for Item 23 is obsolete, the recommendation reflects that this item be rejected. Competitive prices will be solicited for this item, using the current model number, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Benchmarking was completed against the District's previous bid and prices were found to be lower, representing a cost savings of approximately \$4,519.
