**SUBJECT:           AWARD BID NO. 009-EE03 – FRESH-DELIVERED PIZZA, A LA CARTE (REBID)**

The purpose of this bid, opened on November 9, 2004, is to purchase, at firm unit prices, quantities, as may be required, of fresh-delivered pizza, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 199 vendors sent bid forms or card notices of this advertised bid, 12 responded, with 11 regular bids and 1 no bid.

This bid provides various types of pizza to thirty-eight (38) senior high schools, for the a la carte program of the Department of Food and Nutrition. Each school has at least three vendors who have indicated an interest in providing pizza. The vendors range from national chains to small, local vendors. The vendors will be utilized at senior high schools according to student preference, as students request specific brands of pizza for purchase as part of the on-campus food choices provided in addition to the full cafeteria meal service.
