LINK TO DISTRICT STRATEGIC PLAN: IMPROVE CONSTRUCTION AND MAINTENANCE SERVICES

The purpose of this bid is to establish a pool of pre-approved distributors and manufacturers, to purchase a vast range of Maintenance and Repair Operations (MRO) materials, equipment, supplies, parts, and tools, utilized to support Maintenance Operations. These materials will be used to replenish Maintenance Materials Management (MMM) and Stores and Mail Distribution (S&MD) inventory warehouses. This bid addresses new sourcing initiatives to procure materials for maintenance projects, in order to perform work with in-house staff. This is a term bid which states that the Board may purchase material, as may be required, but is not obligated to purchase any guaranteed amount. One hundred seventy-nine (179) vendors responded to this advertised solicitation.

The pre-approved vendors will be contacted to procure MRO materials, based on the category of items they distribute. Purchase requirements greater than the quotation threshold will be solicited through a competitive Request For Quotations (RFQ) process, to establish firm, fixed-price agreements.

The balance of vendors is being held for further evaluation, and will be awarded at a future Board meeting.
