Procurement Management Services, at the request of the Office of School Facilities, released the above-referenced solicitation. The purpose of this Invitation To Bid (ITB) is to establish a contract, at firm unit prices, to furnish labor, supervision, materials equipment and transportation necessary to repair lift stations and related structures, at various Miami-Dade County Public Schools facilities, for Regulatory Compliance. This is a term bid which states that the Board may purchase quantities, as may be needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Miami-Dade County Public Schools Procurement Management Services' website, the DemandStar website, Bid Net and Florida Bid, as well as emailed to 13 potential bidders, which included four (4) SBE/MBE vendors registered to the commodity code(s).

The initial term of the bid shall be for a two (2) year period, commencing May 24, 2017 through May 23, 2019, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidder, be extended for three (3) additional one (1) year periods.

Strategies were employed to increase SBE/MBE participation. The Goal Setting Committee recommended that this solicitation be open with a 30% SBE/MBE participation goal.

One (1) vendor responded to this advertised bid. Based on the criteria listed in the solicitation, the contract shall be awarded to the District's incumbent vendor, who is a Micro Business Enterprise. The SBE/MBE goal was met by 100%.

Unit Price: Items 1 through 6.

- Item 1 - Remove and re-install lift-station column "stick" pumps @ \$225 each.
- Item 2 - Remove and re-install lift-station submersible pumps @ \$300 each.
- Item 3 - Remove and re-install lift station direct/belt-driven pumps @ \$225 each.
- Item 4 - Replace all float switches; 4 per lift station, and adjust for proper operation @ \$345 per set of 4.
- Item 5 - Labor rate per hour for additional services @ \$60 per Hour.
- Item 6 - Percentage of mark-up over cost for individual parts @ 15%.

2. **AUTHORIZE** Procurement Management Services to purchase up to the total estimated amount of \$180,000 for the initial contract term, and an amount not to exceed \$90,000, for each subsequent one (1) year extension period(s). Board authorization of this recommendation does not mean the amount shown will be expended.
