Procurement Management Services, at the request of the Office of Academic Transformation, specifically Information Technology Services, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a list of pre-approved vendors to furnish network connectivity devices, which includes internetworking devices and network adapter cards for various departments servicing the District. This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services' website, the Demandstar website, BidNet, Florida Bid, *The Miami Times* and the *Diario Las Americas* newspapers, as well as e-mailed to 1,096 potential bidders, which included 19 Small Business/Micro Business Enterprise (SBE/MBE) certified vendors that are registered to the IT computer peripheral commodity codes.

The initial term of the bid shall be for a two (2) year period, commencing July 1, 2017 through June 30 2019 and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for three (3) additional one (1) year periods.

Strategies were employed to increase SBE/MBE participation. The Goal Setting Committee recommended that this solicitation be open with a 25% SBE/MBE participation rate and a 10% local preference participation rate.

Seven (7) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract shall be awarded to all seven (7) vendors, of which three (3) of the awarded vendors are SBE/MBE and Minority/Women Business Enterprise (M/WBE) certified. The SBE/MBE goal was exceeded by 29%, and the local preference goal was exceeded by 57%.
