**SUBJECT: AWARD REQUEST FOR PROPOSALS RFP-17-004-CH –
TESTING PLATFORM SERVICES**

Procurement Management Services, at the request of the Department of Assessment, Research and Data Analysis, released the above-referenced solicitation. The purpose of this Request for Proposals (“RFP”) is to select a qualified and experienced firm to provide a web-based assessment item bank and test platform. This RFP was advertised on the Procurement Management Services’ website, the DemandStar website, BidNet, Florida Bid, *South Florida Times* and the *Diario Las Americas* newspapers, as well as emailed to 420 potential bidders.

The initial term of the bid shall be for a three (3) year period, commencing July 1, 2018 through June 30, 2021 and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods.

Strategies were employed to increase SBE/MBE (Small/Micro Business Enterprise) participation. The Goal Setting Committee recommended that this solicitation be open with a 5% SBE/MBE participation rate.

Eleven (11) vendors responded to this solicitation. Based on the evaluation criteria listed in the RFP, oral presentation by the vendor and the selection committee’s recommendation, one (1) vendor was recommended with a subcontractor and one (1) alternate vendor was recommended for award.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the prime firm and all subcontractors.

In FY 2017-2018, the District spent \$2,611,346 on the current testing platform. In year 1 of the recommended testing platform, the District will spend an estimated maximum of \$2,255,163 with a minimum cost savings of \$356,183.
