Procurement Management Services, at the request of Maintenance Operations, released the above-referenced solicitation. The purpose of this Invitation to Bid (“ITB”) is to establish fixed prices for the estimated quantities for installation of chain link fences, gates, accessories, and related services for the School Board of Miami-Dade County, FL. This is a term bid which states that the Board may purchase quantities, as needed and is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services’ website, the DemandStar website, BidNet, Florida Bid, *South Florida Times* and the *Diario Las Americas* newspapers, as well as emailed to 198 potential bidders.

The initial term of the bid shall be for a three (3) year period, commencing December 19, 2018 through December 18, 2021 and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods. At the time of contract extension, additional vendors may be added and/or removed, at the discretion of the District.

Strategies were employed to increase local business participation. The Goal Setting Committee recommended that this solicitation be open with a 10% SBE/MBE and/or 5% local preference participation rate.

Three (3) vendors responded to this solicitation. Based on the criteria listed in the ITB, the contract shall be awarded to one (1) vendor, who is SBE/MWBE certified. The SBE/MBE participation rate of 10% was exceeded, with a participation goal of 100%.

In fiscal year 17-18, the District spent \$293,652.48 on the fencing and gates’ contract.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the prime firm and all subcontractors.
