Procurement Management Services, at the request of the Department of Athletics and Activities, released the above-referenced solicitation. The purpose of this Invitation to Bid ("ITB") is to select qualified and experienced travel agency services for District staff and student travel events. This ITB will replace the Student Travel Services bid ITB-15-011-MT, which expires November 17, 2019. This item rejects the business/District travel portion of ITB-18-032-CM Travel Agency Services, to permit rebidding. This ITB was advertised on the Procurement Management Services' and Demandstar websites. The solicitation was shared with District offices for additional community outreach, including but not limited to social media, local newspapers, local radio stations and prior bid forecasting lists.

The initial term of the bid shall be for a period of three (3) years, commencing July 24, 2019, through July 23, 2022, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods. At the time of contract extension, additional vendors may be added and/or removed, at the discretion of the District.

Strategies were employed to increase SBE/MBE (Small/Micro Business Enterprise) participation. The Goal Setting Committee recommended that this solicitation be open with 5% SBE/MBE, or 5% preference for local vendors.

Thirty-two (32) vendors responded to this advertised bid, of which two (2) were non-responsive. Based on the criteria listed in the ITB, the contract shall be awarded for student travel agency services only to thirty (30) vendors, of which seven (7) are certified.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the prime firm and all subcontractors.
