The following solicitations either employed a methodology that would possibly not result in the best value to the District, or cost was considered excessive under current market conditions. The solicitations will be issued using revised specifications.

INVITATION TO BID NO. ITB-18-070-TR - SCHOOL SECURITY UNIFORMS was released to establish a contract, with a pool of pre-approved vendors for the purchase of school security uniforms for Miami-Dade Public Schools (MDCPS) Security personal.

INVITATION TO BID NO. ITB-18-033-MJ – CLASSROOM EQUIPMENT AND SUPPLIES (CATALOG DISCOUNT) was released to establish a pre-approved vendor list with catalog discounts, to purchase classroom equipment and supplies for Miami-Dade County Public Schools.

INVITATION TO BID NO. ITB-18-027-MJ – ASPHALT PAVING, RESURFACING, AND DRAINAGE was released to establish a pre-approved vendor list for the supply, installation, repair and/or modification of asphalt paving and drainage, as needed, for Miami-Dade County Public Schools' facilities.

INVITATION TO BID NO. ITB-18-037-TR - CLASS RINGS was released to establish a pre-approved vendor list to provide class jewelry services, for Miami-Dade County Public Schools.

INVITATION TO BID NO. ITB-18-046-DP - AUDIO VISUAL EQUIPMENT, SUPPLIES, AND INSTALLATION SERVICES was released to establish a contract providing catalog discounts for audiovisual equipment, supplies, and installation services purchased for the various schools and departments in Miami-Dade County Public Schools.

INVITATION TO BID NO. ITB-18-078-TR - STUDENT AND CLASS PICTURES was released to establish a pre-approved list of vendors to provide student and class picture services for Miami-Dade County Public Schools (MDCPS).

INVITATION TO BID NO. ITB-18-059-TR – POLICE DEPARTMENT UNIFORMS AND EQUIPMENT was released to establish a contract, with a list of pre-approved vendors for the purchase of police department uniforms and equipment for Miami Dade County Public School (MDCPS) police department.

INVITATION TO BID NO. ITB-18-076-MJ – SCHOOL BUS ROUTES FOR PRIVATE SCHOOL BUS COMPANIES was released to purchase at a firm unit price, quantities, as may be required, of school bus routes, for the Department of Transportation of Miami-Dade County Public Schools. The bid specifications utilized did not result in the best pricing to the District and costs were considered excessive under current market conditions. The bid is recommended for rejection in order to reissue with revised specifications and method of award.

REQUEST FOR PROPOSALS NO. RFP-18-030-MT - CRISIS MANAGEMENT AND/OR SPECIAL PROJECTS COMMUNICATION SERVICES was released at the request of the Office of Communications, is to obtain qualified individuals or firms to provide crisis management and/or special projects communication services.

At the June 19, 2019 Board Meeting the Board authorized the renewal of its General/Automobile/Professional Liability/Errors and Omissions coverage with United Educators Risk Retention Group (United Educators) (A.M. Best A, IX for five one-year terms with the first year effective July 1, 2019 through June 30, 2020. The Policy has been endorsed to include Crisis Communication Services covering the scope of services requested in this RFP. The Policy provides payment for services in amounts of up to \$15,000 per incident without preapproval and an additional \$60,000 of coverage upon approval.

This RFP is recommended for rejection to permit inclusion of proposers into pre-approved list via the District's current Crisis Communication Coverage.
