Procurement Management Services, at the request of Maintenance Operations, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a pre-approved vendor list for refrigeration equipment, components, incidental materials and repairs, for Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services' and DemandStar websites. The solicitation was shared with the District offices for additional community outreach, including but not limited to social media, local newspapers, local radio stations and prior bid forecasting lists.

The initial term of the bid shall be for a one (1) year period, commencing April 29, 2020 through April 28, 2021, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for an additional one (1) year period. At the time of contract extension, additional vendors may be added and/or removed, at the discretion of the District.

Strategies were employed to increase SBE/MBE (Small/Micro Business Enterprise) participation. The Goal Setting Committee recommended that this solicitation be sheltered market for SBE/MBE.

Seven (7) vendors responded to this solicitation. Based on the criteria listed in the ITB, the contract shall be awarded to four (4) certified vendors.

In FY 2018-2019, the District spent \$1,004,604 on refrigeration maintenance.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the prime firms.
