Procurement Management Services, at the request of the Office of Communications, released the above-referenced solicitation. The purpose of this Invitation to Negotiate (ITN) is to establish a pre-approved list of agencies to provide promotional planning, shooting and production of video content in support of an outreach campaign, focused on attendance and enrollment, for The School Board of Miami-Dade County, Florida. This ITN was advertised on the Procurement Management Services website, as well as DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a three (3) year period, commencing February 9, 2022 through February 8, 2025, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods, pending contract negotiations.

The Goal Setting Committee recommended that this solicitation be open with a maximum 20 point preference for M-DCPS certified African American or Non-Minority Women owned primary firms and a maximum 20 point preference (based on a participation sliding scale) for use of subcontractors which are M-DCPS certified African American or Non-Minority Women owned firms.

Four (4) vendors responded to this advertised bid. Based on the criteria listed in the solicitation and the Selection Committee's consensus vote, four (4) vendors are being recommended for award, all of which are certified.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).
