Procurement Management Services, at the request of Instructional Technology, Instructional Materials, and Library Media Services released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract at firm fixed prices for the purchase and installation of classroom conferencing cameras for Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase quantities, as may be needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website and DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of three (3) years, commencing April 13, 2022 through April 12, 2025, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods.

The Goal Setting Committee recommended that this solicitation be open with a 5% price preference for M-DCPS-certified African American firms (Primary or Alternate/Provider or Installer) and a 2% price preference for non-MDCPS certified African American firms (Primary or Alternate/Provider or Installer).

Seven (7) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract will be awarded to one (1) vendor.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).
