Procurement Management Services, at the request of Information Technology Services, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a pool of pre-approved vendors for information technology consulting services at Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase services as needed, but is not obligated to purchase any guaranteed amount. Awarded vendors will be contacted through the Request for Quotation (RFQ) process. Per this ITB, projects under \$1,000 will be awarded on a rotating basis. This ITB was advertised on the Procurement Management Services website, as well as DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of three (3) years, commencing July 20, 2022 through July 19, 2025, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two(2) additional one (1) year periods.

The Goal Setting Committee recommended that this solicitation be open with a 5% price preference for M-DCPS certified African American and Non-Minority Women firms to be applied during the RFQ process. In addition, there was an additional 1% price preference for non-MDCPS certified African American and Non-Minority Women firms to be applied during the RFQ process.

Forty-six (46) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract shall be awarded to forty-four (44) vendors meeting the minimum requirements, of which five (5) are MDCPS certified and three (3) non-MDCPS certified.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).
