SUBJECT: AWARD INVITATION TO BID NO. ITB-21-047-RU – ESSER FUNDED IT EQUIPMENT

Procurement Management Services, at the request of the office of Infrastructure and System Support, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish contracts, at a fixed discount off MSRP, for information technology infrastructure equipment, software licenses, and maintenance support, for various sites within Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase quantities, as may be needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, as well as DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of one (1) year, commencing July 20, 2022 through July 19, 2023.

The Goal Setting Committee recommended that this solicitation be open with a 5% price preference for MDCPS-certified African American and Non-Minority Women firms and a 3% price preference for other nationally-certified African American or Non-Minority Women firms.

Three (3) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract will be awarded to two (2) vendors. The District will work with these awarded vendors to encourage spending with minority subcontractors, even though no subcontractors are on the award.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).
