Procurement Management Services, at the request of the Transportation Vehicle Maintenance Department, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract, at firm unit prices, for the purchase of vehicle towing services for Miami Dade County Public Schools. This is a term bid which states that the Board may purchase services as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, as well as DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a three (3) year period, commencing July 20, 2022 through July 19, 2025, and may, by mutual agreement between The School Board of Miami-Dade County, Florida and the successful bidders, be extended for two (2) additional one (1) year period(s) and, if needed, an additional ninety (90) days beyond the expiration date of the current contract period.

The Goal Setting Committee recommended that this solicitation be open with a 3% price preference for M-DCPS certified SBE/MBE firms.

Four (4) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract shall be awarded to two (2) vendors, of which one is certified.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).
