The purpose of this request is to obtain approval of a supplemental award on the following term contract, inasmuch as the estimated requirements, previously awarded by the Board, will be exceeded before the contract extension term(s) expires. Due to increased pricing, this supplement is required to purchase refrigerant gases for Miami-Dade County Public Schools' Maintenance Material Management stock, as the current total approved amount of \$300,000 per year will be exhausted before the term expires. Given the current market conditions and volatility in this industry, the cost of items has increased significantly. This request amends the total contract award to \$1,700,000 annually.
