SUBJECT: REQUEST APPROVAL OF SUPPLEMENTAL AWARD ON INVITATION TO BID NO. ITB-19-006-MV – TREE, PALM, AND SHRUB PRUNING/REMOVAL

The purpose of this request is to obtain approval of a supplemental award on the following term contract, inasmuch as the estimated requirements, previously awarded by the Board, will be exceeded before the contract extension term(s) expires. Due to increased pricing, this supplement is required in order to furnish tree, palm, and shrub trimming, pruning and stump removal services, and amend the total contract award to \$1,250,000 annually. In addition, there is an estimated budget of \$1,280,000 for the continuation of the Districtwide effort to expedite deferred maintenance of school facilities. The increase in budget will assist with our targeted enrollment initiative to beautify our school facilities.
