Procurement Management Services, at the request of District Inspections, Operations and Emergency Management, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish contracts, at firm prices, for recycling, solid waste, and roll-off container collection services for Miami-Dade County Public Schools' locations. This is a term bid which states that the Board may purchase services, as may be needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, as well as DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of five (5) years, commencing January 9, 2023 through January 8, 2028, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for one (1) additional three (3) year period.

The Goal Setting Committee recommended that this solicitation be open with a 10% price preference for M-DCPS SBE/MBE certified firms and a 5% price preference for firm using M-DCPS SBE/MBE certified subcontractors.

Seven (7) vendors responded to this advertised bid, of which one (1) was a no bid and one (1) was non-responsive. Based on the criteria listed in the solicitation, the contract will be awarded to three (3) vendors.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).

In Fiscal Year 2021-2022, the District spent \$5,574,353 on solid waste, recycling and roll-off collection services.
