Procurement Management Services, at the request of the Office of Assessment Research and Data Analysis, released the above-referenced solicitation. The purpose of this Request for Proposals (RFP) is to develop a pre-approved pool of qualified evaluation consultants to provide program evaluation services, including but not limited to, carrying out needs assessments, developing evaluation plans and research designs, collecting data, analyzing data, interpreting results, and preparing recommendations and reports, as described in this RFP, on an as needed basis, during the term of the contract. This RFP was advertised on the Procurement Management Services website and DemandStar. This contract impacts all District students on an as needed basis. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a three (3) year period, commencing upon contract execution, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods, and if needed, an additional ninety (90) days beyond the expiration of the renewal period.

Pursuant to School Board Policy 6320.02, the Goal Setting Committee recommended that this solicitation be open with a 5 point preference for SBE/MBE certified firms.

Twelve (12) vendors responded to this advertised bid. M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s). Based on the criteria listed in the solicitation and the Selection Committee's consensus recommendation, three (3) vendors were deemed non-responsive and nine (9) vendors are being recommended for award, of which one (1) is certified.

In Fiscal Year 2022-2023, the District spent \$870,630 on external program evaluation services.

## Fund Source

Funding will be made available through grant opportunities, with a majority of the funding



coming from federal grants.
