## **INSTRUCTIONS TO AGENCY/PROPOSER SUBMITTING PROPOSAL**

### **I. PREPARING OF PROPOSALS**

- A. THE PROPOSAL IS TO BE SUBMITTED, using 8-1/2" x 11" paper.
- B. IDENTIFICATION. Failure to indicate the contractor's EXACT legal name and an unsigned proposal may be considered non-responsive.

### **II. SUBMITTING OF PROPOSALS**

- A. Number of Proposals:

A total of (12) copies of the Proposal must be submitted as follows:

- \* The original proposal in a sealed envelope or box marked "Original."
- \*\* (11) copies of the proposal in a separate sealed envelope or box marked "Copies."

The proposal number, proposal title and opening date must be clearly marked on all envelopes and boxes.

- B. Place, Date and Hour. Proposals shall be submitted to The School Board of Miami-Dade County, Florida, Procurement Management, Room 352, 1450 N.E. 2nd Avenue, Miami, Florida, not later than 2:00 P.M. April 10, 2007.

### **III. CHANGE OR WITHDRAWAL OF PROPOSAL**

- A. PRIOR TO PROPOSAL OPENING. Should the agency or individual contractor withdraw its proposal, they shall do so in writing. This communication is to be received by the Assistant Superintendent, Procurement Management Services, 1450 N.E. 2nd Avenue, prior to April 10, 2007. The agency or individual contractor's name and the proposal number should appear on the envelope.
- B. AFTER PROPOSAL OPENING. After April 10, 2007, proposals may not be changed; and they may not be withdrawn for one hundred twenty (120) days from that date.

#### **IV PROTEST TO CONTRACT SOLICITATION OR AWARD**

- A. The Board shall provide notice of a decision or intended decision concerning a solicitation, contract award, or exceptional purchase by electronic posting. This notice shall contain the following statement:

"Failure to file a protest within the time prescribed in § 120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes."

- B. Any person who is adversely affected by the agency decision or intended decision, shall file with the agency a notice of protest in writing within 72 hours after the posting of the notice of decision or intended decision. With respect to a protest of the terms, conditions, and specifications contained in a solicitation, including any provisions governing the methods of ranking proposals or replies, awarding contracts, reserving rights of further negotiation or modifying or amending any contract, the notice of protest shall be filed in writing within 72 hours after the posting of the solicitation. The formal written protest shall be filed within 10 days after the date of the notice of protest is filed. Failure to file a notice of protest or failure to file a formal written protest shall constitute a waiver of proceedings. The formal written protest shall state with particularity the facts and law upon which the protest is based. Saturdays, Sundays, and state holidays shall be excluded in the computation of the 72-hour time periods provided by this paragraph.
- C. The formal written protest will be reviewed by Procurement Management Services staff, which will offer the protesting proposer the opportunity to meet and discuss the merits of the protest. If the protest is not resolved, the proposer may seek an administrative hearing pursuant to 120.57 Florida Statutes, by filing a formal written protest within 10 days after filing the notice of protest. Petitions for hearings on protests pursuant to 120.57 Florida Statutes must be filed in accordance with School Board Rule 6Gx13-8C-1064.

#### **V. AWARDS**

- A. **RESERVATION FOR REJECTION OR AWARD.** The Board reserves the right to reject any and all proposals, to waive irregularities or technicalities, and to request re-bids.
- B. **NOTIFICATION OF INTENDED ACTION.** Notices will be posted on the District's website 7-10 days prior to a regularly scheduled Board meeting.
- C. **OFFICIAL AWARD DATE.** Awards become official upon Board action.
- D. **CHARTER SCHOOLS:** Items awarded under this contract shall be made available to charter schools authorized by the School Board.

## **VI. DEFAULT**

In the event of default, which may include, but is not limited to non-performance and/or poor performance, the awardee shall lose eligibility to transact new business with the Board for a period of 14 months from date of termination of award by the Board. Proposers that are determined ineligible may request a hearing pursuant to §120.569, Fla. Stat., and School Board Rule 6Gx13-8C-1.064.

## **VII. PUBLIC ENTITY CRIMES**

**Section 287.133(2)(a) Florida Statute.** A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017, for CATEGORY TWO for a period of 36 months from the date of being placed on the convicted vendor list.

## **VIII. COMPLIANCE WITH FEDERAL REGULATIONS**

All contracts involving Federal funds will contain certain provisions required by applicable sections of Title 34, Section 80.36(l) and Section 85.510 Code of Federal Regulations and are included by reference herein. The vendor certifies by signing the proposal that the vendor and its principals are not presently debarred, suspended, proposed for debarment, declared ineligible or voluntarily excluded from participation in Federally funded transactions and may, in certain instances, be required to provide a separate written certification to this effect.

During the term of any contract with the Board, in the event of debarment, suspension, proposed debarment, declared ineligible or voluntarily excluded from participation in Federally funded transactions, the vendor shall immediately notify the Assistant Superintendent, Procurement Management Services, in writing.

Vendors will also be required to provide access to records, which are directly pertinent to the contract and retain all required records for three years after the grantee (The Board) or sub-grantee makes final payment.

For all contracts involving Federal funds, in excess of \$10,000, The Board reserves the right to terminate the contract for cause as well as for convenience by issuing a certified notice to the vendor.

**IX. CONE OF SILENCE**  
**BOARD RULE 6GX13-8C-1.212**

**DEFINITION:**

A. "Cone of Silence" means a prohibition on any communication regarding a particular Request for Proposals (RFP), bid, or other competitive solicitation between:

1. any person who seeks an award therefrom, including a potential vendor or vendor's representative; and
2. any School Board member or the member's staff, the Superintendent, Deputy Superintendent and their respective support staff, or any person appointed by the School Board to evaluate or recommend selection in such procurement process.

The Cone of Silence shall not apply to communication with the School Board Attorney or his or her staff, or with designated school district staff, who are not serving on the particular Procurement Committee, to obtain clarification or information concerning the subject solicitation. For purposes of this section, "vendor's representative" means an employee, partner, director, or officer of a potential vendor, or consultant, lobbyist, or actual or potential subcontractor or sub-consultant of a vendor, or any other individual acting through or on behalf of any person seeking an award.

B. A Cone of Silence shall be applicable to each RFP, bid, or other competitive solicitation during the solicitation and review of bid proposals. At the time of issuance of the solicitation, the Superintendent or the Superintendent's designee shall provide public notice of the Cone of Silence. The Superintendent shall include in any advertisement and public solicitation for goods and services a statement disclosing the requirements of this section.

C. The Cone of Silence shall terminate at the time the Superintendent of Schools submits a written recommendation to award or approve a contract, to reject all bids or responses, or otherwise takes action which ends the solicitation and review process.

D. Nothing contained herein shall prohibit any potential vendor or vendor's representative:

1. from making public representations at duly noticed pre-bid conferences or before duly noticed selection and negotiation committee meetings;
2. from engaging in contract negotiations during any duly noticed public meeting;
3. from making a public presentation to the School Board during any duly noticed public meeting; or
4. from communicating in writing with any school district employee or official for purposes of seeking clarification or additional information, subject to the provisions of the applicable RFP, or bid documents.

The potential vendor or vendor's representative shall file a copy of any written communication with the School Board Clerk who shall make copies available to the public upon request.

- E. Nothing contained herein shall prohibit the Procurement Committee's representative from initiating contact with a potential vendor or vendor's representative and subsequent communication related thereto for the purposes of obtaining further clarifying information regarding a response to an RFP, or competitive solicitation. Such contact shall be in writing and shall be provided to the members of the applicable Procurement Committee, including any response thereto.
- F. Any violation of this rule shall be investigated by the School Board's Inspector General and may result in any recommendation for award, or any RFP award, or bid award to said potential vendor or vendor's representative being deemed void or voidable. The potential vendor or vendor's representative determined to have violated this rule, shall be subject to debarment. In addition to any other penalty provided by law, violation of this rule by a school district employee shall subject the employee to disciplinary action up to and including dismissal.

**II. PURPOSE OF REQUEST FOR PROPOSALS**

The purpose of this Request For Proposals (RFP) is to solicit proposals from firms qualified to serve as The School Board of Miami-Dade County Public Schools' (the "District" or "M-DCPS") marketing agent, to generate new revenues and resources through the solicitation of an exclusive beverage pouring rights partnership arrangement with a major beverage manufacturer, and to administer revenue producing sponsorship and advertising of M-DCPS physical education, athletic, and educational programs, over a consecutive ten (10) year period. The marketing agent would have the authority to solicit and negotiate favorable terms, on behalf of the District and insure that any process for entry into such opportunities is an open and fair process and achieves fair and reasonable compensation for the District. M-DCPS anticipates entering into an agreement with one marketing firm.

The marketing agent will also solicit soft advertisement, if approved by the Board, that markets goods and services in the context of Board-approved educational, inspirational, motivational and/or student athlete messages, slogans, mottoes, illustrations, photographs, holograms, designs and/or images directed at, and for the benefit of, students, student athletes, parents, school district employees, and members of the general public.

**III. INSTRUCTIONS FOR SUBMISSION OF PROPOSALS**

Proposers should include in their proposals a Table of Contents and page numbers. Although there is no specific limit on the number of pages that proposals may contain, Proposers are encouraged to be as concise as possible.

The responsibility for submitting this proposal to the District on or before the stated time and date will be solely and strictly the responsibility of the Proposer. The District will not be responsible for delays caused by the United States Post Office or any other delivery service or for delays resulting from any other occurrence. The proposal must be submitted in a sealed envelope or box marked **"ADVERTISING, SALES AND ADMINISTRATION - EXCLUSIVE BEVERAGE POURING RIGHTS FOR MIAMI-DADE COUNTY PUBLIC SCHOOLS VENDING PROGRAM."**

The School Board of Miami-Dade County, Florida will not be held liable for any pre-contract activity or costs incurred by the Proposers in the preparation of their proposals, or during any negotiations on proposed contracts, or for any work performed or materials provided in connection therewith.

It is anticipated that a proposal may be presented to The School Board of Miami-Dade County, Florida, for acceptance on or about May 16, 2007. In the event that the proposal is accepted, notice to the successful proposer(s) will be sent on or about May 16, 2007. The Board reserves the right to accept or reject any and all proposals.

#### **IV. BACKGROUND INFORMATION**

The School Board of Miami-Dade County, Florida, is the fourth largest school system in the nation. The district has approximately 367 schools, charter schools, alternative schools, and exceptional student education centers; approximately 361,550 students and more than 57,372 full and part-time employees. The student population is economically, ethnically, and linguistically diverse, with the largest ethnic group being Hispanic students. Additionally, M-DCPS sponsors extensive adult training programs through its Adult Technical Centers. These programs are offered both day and evening on a full time and part time basis

In response to the growing concerns regarding childhood obesity and other serious health related issues, the School Board of Miami-Dade County Public Schools has initiated a Health and Wellness Policy effective July 1, 2006 for all food and beverage sales before, during and 1 hour after school. The District is committed to providing an environment in which all students can make healthy food choices for lifelong health and possible prevention of future adult type illnesses related to unhealthy choices made as a child.

The District expects future revenue benefits to accrue from exclusivity premium driven by both the value of the contract and future value from the opportunity to lock-up long-term brand name loyalty among youthful consumers, adult students, employees, visitors, etc. and added-value resources offered by the beverage provider to support excellence by M-DCPS students and employees. M-DCPS expects respondents to this RFP to quantify these projections and benefits over a ten (10) year schedule.

## V. SCOPE OF SERVICES

The marketing agent is expected to develop financial support for Miami-Dade County Schools, generating new revenues and resources through the solicitation of potential sponsors and donations. As part of a large-scale business partnership arrangement, with exclusivity terms, an exclusivity premium in the form of a series of cash payments is desirable to the Board. As part of the long-term arrangement, the Board would expect the beverage provider to pay out a percentage of the exclusivity premium upon execution of the contract with M-DCPS (up-front dollars), with the balance paid out equally over successive years of the agreement at the start of each fiscal year or period.

- A. The successful marketing agent shall solicit and assist the Board in negotiating a long-term beverage exclusivity arrangement to obtain **revenue** from the **exclusive beverage pouring rights** of stated products in the district's vending program. The exclusive beverage pouring rights will encompass the vending program at all District school sites and administrative facilities. The exclusivity arrangement with a major beverage company shall be for the purchase of, and pouring rights for, beverages only in vending machines, fountain dispensing units or other beverage vending operations on District-owned school campuses, adult centers and administrative buildings. .

Any beverage meeting the nutritional guidelines as defined in the district's Health and Wellness Policy (**Attachment A**), shall be approved for sale in the student access areas of M-DCPS. The student access areas are defined as senior high schools, middle schools, athletic areas, gymnasiums, vocational sites and all miscellaneous sites where students have access to vending machines. There are no restrictions for beverages sold in non-student access areas. The non-student access areas are defined as administrative offices, transportation offices, maintenance offices, construction offices, teacher lounges, etc.

The marketing agent shall have the flexibility to solicit and negotiate with sponsors for **exclusive pouring rights on Milk-Based beverages only; Non-Milk Based beverages only or a combination of both, as there will be both types of products sold in the District's student access areas. Non-student access sites may stock any item agreed upon by the site administrator.**

The beverage company will have the sole, exclusive rights to place any advertising on the front, back or side panels of the enclosures and of the vending machines located at student access sites, with the final written approval by the Department of Food and Nutrition. Non-student access sites must have the approval of the site administrator.

The beverage company must adhere to District guidelines as pertains to signage, which prohibits offensive or tasteless language or pictures. Brand type signage is acceptable but must display items within the perimeter of healthy choices in student-access areas.

The beverage company may provide additional marketing material, i.e. shirts, cups, lunch boxes, etc. All items must be approved by the administrative designee at the Department of Food and Nutrition by submitting a sample of one item with all pertinent information, quantities, method of distribution, amounts, etc. **No items will be permitted to be distributed without prior approval by the Department of Food and Nutrition for student access areas.**

M-DCPS will limit the negotiated Beverage provider's school-site "micro marketing" efforts to the equipment (vending machines) and any signage, school publications or student/faculty recognition approved by officials at a given school. M-DCPS will not tolerate any wholesale marketing efforts designed to aggressively market the student base for the purpose of generating volume. Discretionary purchases are intended to be the primary purpose of product sales to ensure Beverage providers do not take advantage of M-DCPS students as a captive audience.

- B. The marketing agent shall also solicit corporate support for enhancement of the Greater Miami Athletic Conference (GMAC) and the athletic sports and physical education programs of Miami-Dade County Public Schools. The Board is seeking new or expanded revenue sources for these programs. The program should be designed to produce risk-free revenue streams for the Board.

With respect primarily to M-DCPS senior high school athletic and special events, annual support bundled in the form of cases of product donations, cups, sports drink incentives, concession ice machines and scoreboards, etc., have traditionally been a central component of past beverage provider contracts. These arrangements are not in place with beverage providers District-wide. Under an exclusivity agreement, the District intends to ensure that each school principal receives greater service revenue and enhancements annually over previous revenues.

- C. Manage implementation of the program. The marketing agent shall create the marketing collateral necessary to execute the marketing plan; make presentations to potential partners; respond to requests to additional qualifications from potential partners; and work with the Board and its representatives to negotiate favorable agreements between the Board and potential partners.
- D. The marketing agent shall develop a coherent marketing/business plan to attract paying sponsors to promote/merchandise goods and services centered on the Miami-Dade County Public Schools physical education programs and the related programs, including, if permissible, "soft advertisements". Create an inventory of the Board's marketable assets. Define the target market(s) for marketing

partnerships; create offers that meet the marketing needs of corporations within the target market(s); create a list of corporations that make attractive partners and estimate revenues that may accrue to the Board from the program.

Soft goods, services and advertisement, may include, without limitation, the following:

- Soft Drinks
- Apparel & Furnishings, e.g., general men's women's and children's clothing and furnishings, sportswear, and athletic shoes
- Fast food, including ice cream
- Sports Equipment
- Electronic Equipment
- Computer hardware, software & peripherals
- Photographic equipment and supplies
- Automobiles, trucks, sport utility vehicles, automotive parts, supplies, fuel And lubricants
- Oral hygiene products, e.g., toothpaste and mouthwash
- First aid products
- Non-prescriptive medicines
- Wrist watches
- Writing implements
- Personal care products
- Publications, e.g., books and magazines
- Popular, classical and other music, e.g., CDs, cassette tapes and vinyl records
- Furniture, carpeting, rugs and home furnishings
- General consumer foods, beverages & dry goods
- Office and business products

The sponsorship of goods and services shall not contain, display or constitute anything of a nature or intent that is obscene, profane, vulgar, prurient, defamatory, abusive, impolite or discriminatory, as such will be determined within the sole discretion of the Department of Food and Nutrition.

Disapproved sponsor or product service category examples include, without limitation, the following:

- Tobacco, e.g., cigarettes, cigars, chewing tobacco, pipes and pipe tobacco, & rolling paper and all other smoking accessories
- Liquor and other alcoholic beverages & products
- Firearms and all other forms of weaponry
- Condoms, prophylactics and other birth control devices & products
- Pornographic and other adult publications
- Pornographic and other adult video, audio, computer

- E. The marketing agent will be required to meet with the Board's representatives and provide detailed status reports summarizing its progress on a regular basis. The marketing agent shall give the Board the right to inspect, examine and audit all accounting records upon request.
- F. Provide on-going coordination with clients to insure proper functioning of their sponsorship relationship with M-DCPS that adheres to the guidelines set forth by M-DCPS.

**VI. REQUIRED INFORMATION TO BE SUBMITTED BY PROPOSERS:**

All proposals must be prepared and submitted in accordance with the instructions provided in this RFP. Each proposal received will be reviewed to determine if the proposal is responsive to the submission requirements outlined in the RFP. A responsive proposal is one that follows the requirements of the RFP, includes all documentation, supporting exhibits, is of timely submission and has the appropriate signatures as required on each document. Failure to comply with these requirements may deem your proposal non-responsive. Proposer is requested to supply response in same order as below to facilitate evaluation process. Proposer is requested to provide sufficient detail in their response.

- A. **Program Plan/Narrative** – The narrative must be a clear and concise program description that addresses the Proposer's overall program content, methodology, program design, scope of services, ability to perform all required services, and comprehensive service plan. Each proposal should evince a clear understanding of the needs noted in this RFP and demonstrate how your plan will meet the goals and objectives of this particular RFP. Proposals should contain a work plan for the 2007-2008 school year and include but not be limited to the following:
  - 1. Proposed timeline for the business and marketing plan to be implemented
  - 2. Personnel available for this project indicating their level of technical expertise and experience working on this or similar projects
  - 3. Comprehensive outline of the services to be provided.
- B. **Organizational Capacity** – The Organizational capacity should show evidence of adequate human, organizational and technical resources and professional ability to meet the needs of this RFP. The Organizational description must include, but need not be limited to the following:
  - 1. An organizational chart for the overall company responding to the RFP, showing the specific members of the organization slated to work on this project

2. Resumes of key personnel
3. Designation of a project coordinator
4. Type of company, (owned, public, private, corporation)
5. Please indicate whether or not there has been any legal action against your company during the past five (5) years. If so, please explain.

C. **Demonstrated Effectiveness** – Proposal must include a description of all prior experience in the provision of these or similar services for clients of for-profit, not-for-profit, or large educational organizations, whose gross annual revenue/budget exceeds ten (10) million dollars. At a minimum, this should include:

1. Background and experience of the Proposer in providing these services. Firms must have a minimum of three (3) years experience. Please indicate the scope and service of current and prior contracts. The dollar value of gross sponsorship, advertising sales, or exclusivity arrangements with other public agencies should be indicated, where permissible.
2. Proposer should include comparable information regarding experience in other forms of advertising, as relevant.
3. Sample(s) of prior goods and services developed for other clients. Provide examples of recommendations offered to the client and the results of the implementation of those recommendations.
4. Time period for which the projects were conducted.
5. Letters of reference from at least three funding sources/clients.

D. **Fiscal Plan** – Proposer must submit a projected revenue generation plan for the services provided. In return for the exclusive rights to market the M-DCPS program/name to potential sponsors, advertisers, beverage companies, the Proposer must indicate the following:

1. Costs, if any, chargeable to M-DCPS
2. Minimum guaranteed dollar amounts M-DCPS would receive over the course of the ten (10) year contract period
3. Projected revenues over the first two years of the contract
4. Percentage of gross receipts M-DCPS will receive
5. Alternative revenue sharing plans proposed to M-DCPS.

E. **Insurance Requirements** – The Proposer shall submit evidence of current insurance coverage. Prior to award of the contract, if the Proposer's current insurance does not meet the requirement stated in the RFP, the Proposer shall acquire the insurance coverage.

F. **Payment and Compensation** Provide a method and rate of compensation (i.e., monthly retainer, commission or both). The Board will negotiate all matters related to payment and compensation with the selected Proposer.

## **VII. CONTRACT AWARD**

The contract resulting from this solicitation shall be awarded to the qualified proposer whose proposal The School Board of Miami-Dade County, Florida, has determined to be the most advantageous, based on the evaluation criteria set forth in the Request For Proposals. The contract resulting from this RFP shall be signed by the Proposer within a reasonable time upon receipt, which period shall not exceed thirty (30) days. Thereafter, the Proposer is deemed delinquent, and at The School Board's option, the contract may be voided.

No award will be made to any person, firm or corporation that is in arrears or is in default with the Board or any other governmental or state agency upon any debt or contract or that is a defaulter on any other contract with the Board.

## **VIII. TERMS OF CONTRACT**

The term of the contract shall be for an initial five-year period and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the awardee, be extended for an additional 5-year period. The proposer must comply with all municipal, state and federal statutes prohibiting discrimination, including, but not limited to discrimination based on race, religion, ethnicity, national origin and gender.

## **IX. TERMINATION OF CONTRACT**

School Board reserves the right to cancel the contract in the event the services rendered do not comply with the provisions of the proposal and/or the quality of services are deemed inadequate. Any contract(s) resulting from this RFP may be terminated at any time upon thirty (30) days written notice, by the Superintendent, and/or designee. No claim shall be made by, or allowed to, the Proposer because of such termination.

## **X. NEGOTIATIONS**

The School Board of Miami-Dade County, Florida reserves the right to:

- Reject all proposals submitted
- Accept any proposal or alternate as submitted without negotiations
- Accept or negotiate with all proposals submitted which fall within a competitive range
- Require revisions to, corrections of, or other changes to any proposal submitted as a conditions of its being given any further consideration
- Select for negotiations only the overall best proposal or alternate submitted,

- as determined by Miami-Dade County Public Schools
- Negotiate with one or more Proposers in any manner it deems fit (such negotiations may be concurrent or sequential as The School Board of Miami-Dade County, Florida determines
- Following such negotiations, solicit Best and Final Offers

No Proposer shall have any rights against The School Board of Miami-Dade County, Florida, arising at any stage of the solicitation from any negotiations that take place, or from the fact that the Board does not select a Proposer for negotiations.

## **IX. EVALUATION OF PROPOSALS**

All proposals accepted by The School Board of Miami-Dade County, Florida will be reviewed to determine eligible agencies that meet all of the submission requirements prescribed in the RFP. An Evaluation Committee composed of representatives from M-DCPS will evaluate and rate all proposals under consideration, applying the evaluation criteria prescribed below. M-DCPS may require a Proposer to make an oral presentation in support of a proposal.

Upon completion of the above evaluation, rating and ranking, the Committee may choose to conduct an oral presentation(s) with the Proposer(s) which the Selection Committee deems to warrant further consideration based on the best rated proposal(s) providing the best value to the District; scores in clusters; significant breaks in scoring; and/or maintaining competition. Upon completion of the oral presentation(s), the Committee may re-evaluate, re-rate and re-rank the proposals remaining in consideration based upon the written documents combined with the oral presentation to determine overall ranking

The School Board reserves the right to reject any or all proposals, to further negotiate proposals by the successful proposer(s) for terms more favorable to the District, to waive any irregularities or informalities, to accept or reject any items or combination of items, to request clarification of information submitted in any proposal and to request additional information from any proposer. Following the selection of a proposal and approval by the School Board, a professional services agreement acceptable to the School Board Attorney will be entered into with the successful proposer. Unsuccessful proposers will not receive additional information following the issuance of a final decision.

## **XII. EQUAL EMPLOYMENT OPPORTUNITY AND M/WBE PARTICIPATION**

### **Equal Employment Opportunity**

1. It is the policy of the School Board that no person will be denied access, employment, training, or promotion on the basis of gender, race, color, religion, ethnic or national origin, political beliefs, marital status, age, sexual orientation, social and family background, linguistic preference or disability, and that merit principles will be followed.

### **XIII. GENERAL INSURANCE REQUIREMENTS**

#### **Professional Liability**

The Professional Liability Insurance provided by the individual/firm shall conform to the following requirements:

- A. The individual firm's Professional Liability insurance shall be on a form acceptable to the Board and shall cover those sources of liability typically insured by Professional Liability Insurance, arising out of or the rendering or failure to render professional services in the performance of this agreement, including all provisions of indemnification which is part of this agreement.
- B. The insurance shall be subject to a maximum deductible not to exceed \$25,000.
- C. If on a claims-made basis, the individual/firm shall maintain without interruption, the Professional Liability Insurance until (3) years after this agreement.
- D. The minimum limits to be maintained by the individual/firm (inclusive of any amounts provided by an umbrella or excess policy) shall be \$1 million per claim/annual aggregate.

Each insurance policy evidencing the insurance required hereunder shall bear the appropriate endorsements whereby the insurance carrier waives any rights of subrogation acquired against the Board and the Students by reason of any payment under such policy and shall provide that such insurance carriers shall notify the Board in writing at least (30) days prior to any cancellation, termination, non-renewal or modification to the individual/firm's policy (ies) required under this agreement.

Upon the execution of this agreement, the individual/firm shall furnish to the Board's Office of Risk and Benefits Management with Certificates of Insurance evidencing the individual/firm's insurance coverage is consistent with the terms of the agreement. The individual/firm shall also provide copies of the policies to the Board. The individual/firm shall also provide the Board with renewal or replacement Certificates of Insurance no less than (30) days prior to cancellation, termination or modification. The individual/firm shall be in material breach of this agreement if the individual/firm fails to obtain replacement insurance coverage prior to the date in which coverage is terminated or expires. In this event the Board may terminate this agreement without further liability to the individual/firm. Additionally the individual/firm shall be liable to the Board for any and all damages incurred due to the individual/firm's failure to perform the agreement terms.

#### **XIV. INDEMNIFICATION**

The individual/firm(s) must enter into the following indemnification and hold harmless agreement:

The individual/firm(s) hereby agrees to indemnify, hold harmless and defend the Board, its officers, agents and employees individually and collectively from and against all liabilities, obligations, losses, damages, penalties, interest, claims, actions, assessments, fines, suits, demands, investigations, proceedings, judgments, orders or injuries, including death to any, or damage, of whatever nature, to any property and all costs including court costs and attorneys' fees, and disbursements, whether suit is instituted or not, and if instituted, at all tribunal levels (wherever raised by the parties hereto or a third party) imposed on, or incurred by or asserted against the Board or any of them arising out of or in connection with or based directly or indirectly upon (a) the individual/firm's directors, officers, employees, agents, subcontractors or representatives, of their duties and obligations under or pursuant to this agreement, including without limitations, the failure to maintain insurance or notify the Board; (b) any material breach of this agreement by the individual/firm(s), (c) false or inaccurate representation or warranty made by or on behalf of the individual/firm(s), and (d) any act or omission, negligence, or intentional acts of the individual/firm(s), or any of the individual/firm's directors, officers, employees, agents, subcontractors or other representatives.

#### **XV. OCCUPATIONAL LICENSE:**

Any person, firm, corporation or joint venture, with a business location in Miami-Dade County, Florida, which is submitting a bid, shall meet the County's Occupational License Tax requirements in accordance with Chapter 8A, Article IX of the Code of Miami-Dade County, Florida. Bidders with a location outside Miami-Dade County shall meet their local Occupational Tax requirements. A copy of the license is requested to be submitted with the Bid Proposal. If the Bidder has already complied with this requirement, a new copy is not required while the license is valid and in effect. It is the Bidder's responsibility to resubmit a copy of a new license after expiration or termination of the current license. Non-compliance with this condition may cause the bid not to be considered for award.

#### **XVI. LICENSES, PERMITS AND FEES:**

The successful vendor(s) shall obtain and pay for all licenses, permits and fees required for vending service and shall comply with all laws, ordinances, regulations. The successful vendor(s) shall pay all federal, state and local taxes chargeable to the operation. The Board will not collect or pay any sales tax for the awarded vendor(s). Damages, penalties and/or fines imposed on the Board or the awarded vendor(s) for failure to obtain required licenses, permits or fines shall be borne by the vendor.

## **XVII. THE JESSICA LUNSFORD ACT BACKGROUND SCREENING REQUIREMENTS**

In accordance with the requirements of sections 1012.32, 1012.465, and 435.04, Florida Statutes (2004) as well as with the requirements of HB 1877, The Jessica Lunsford Act (2005), effective September 1, 2005, Contractor agrees to certify under oath and penalty of perjury, see **ATTACHMENT D** (Sworn Statement Pursuant to Sections 1012.32, 1012.465, and 435.04, Florida Statutes (2004) and HB 1877, The Jessica Lunsford Act (2005)) which is incorporated fully herein by reference, that Contractor and all of its employees who provide or may provide services under this Agreement have completed all background screening requirements as outlined in the above-referenced statutes.

Additionally, Contractor agrees that each of its employees, representatives, agents, subcontractors or suppliers who are permitted access on school grounds when students are present, who have direct contact with students or who have access to or control of school funds must meet level 2 screening requirements as described in sections 1012.32 and 435.04, Florida Statutes, and further upon obtaining level 2 clearance, must obtain a required Board issued photo identification badge which shall be worn by the individual at all times while on Board property when students are present.

Contractor agrees to bear any and all costs associated with acquiring the required background screening – including any costs associated with fingerprinting and obtaining the required photo identification badge. Contractor agrees to require all its affected employees to sign a statement, as a condition of employment with Contractor in relation to performance under this Agreement, agreeing that the employee will abide by the heretofore described background screening requirements, and also agreeing that the employee will notify the Contractor/Employer of any arrest(s) or conviction(s) of any offense enumerated in s. 435.04, Florida Statutes within 48 hours of its occurrence.

Contractor agrees to provide the Board with a list of all of its employees who have completed background screening as required by the above-referenced statutes and who meet the statutory requirements contained therein. Contractor agrees that it has an ongoing duty to maintain and update these lists as new employees are hired and in the event that any previously screened employee fails to meet the statutory standards. Contractor further agrees to notify the Board immediately upon becoming aware that one of its employees who was previously certified as completing the background check and meeting the statutory standards is subsequently arrested or convicted of any disqualifying offense. Failure by Contractor to notify the Board of such arrest or conviction within 48 hours of being put on notice and within 5 business days of the occurrence of a qualifying arrest or conviction shall constitute grounds for immediate termination of this Agreement by the Board.

The parties further agree that failure by Contractor to perform any of the duties described in this section shall constitute a material breach of the Agreement entitling the Board to terminate this Agreement immediately with no further responsibility to make payment or perform any other duties under this Agreement.

## **COMPLIANCE WITH SCHOOL CODE**

Contractor agrees to comply with all sections of the Florida K-20 Education Code, Title XLVIII, Florida Statutes, as it presently exists, and further as it may be amended from time to time. Further Contractor agrees that failure to comply with the Florida K-20 Education Code shall constitute a material breach of this Agreement and may result in the termination of this Agreement by the Board.

## **XVIII. CONFLICT OF INTEREST**

Former Miami-Dade County Public Schools employees, classified as Managerial Exempt Personnel, Pay Grade 22 and above, Dade County School Administrators Association, Pay Grade 47 and above, and other equivalent positions, are prohibited from personally representing another person or entity or acting as an agent or attorney for compensation in connection with any matter in which The School Board of Miami-Dade County, Florida, is interested, for two years after the School Board employees' service terminates. This provision is pursuant to School Board Rule 6Gx13 – 4A-1.212 and Florida Statute § 112.313(9).

The School Board of Miami-Dade County, Florida shall be prohibited from entering into any business relationship or continue an existing business relationship with any person or entity determined to have engaged in violation of the restriction contained in this provision.

## **XIX. PUBLIC RECORDS LAW**

It is the practice of The School Board of Miami-Dade County, Florida, to evaluate all Requests For Proposals in a public forum open to the Sunshine, pursuant to Florida Statute §286.011, and to make available for public inspection and copying any information received in response to an RFP, in accordance with Florida Statute §119, as such, any information sent to M-DCPS is being sent into the public domain. No action on the part of the proposer would create an obligation of confidentiality on the part of the School Board, including but not limited to, making a reference in the proposal to the trade secret statutes, Florida Statutes §§ 812.081, 815.045. It is recommended that potential suppliers exclude from their response any information that, in their judgment, may be considered a trade secret.

- Drinking water with no additives except those minerals normally added to tap water.
- Electrolyte replacement drinks that do not contain more than 34 grams of added sweetener per 16 ounce serving; 16 ounce maximum volume.
- Milk and flavored milks, all milk should contain Vitamin A and D at levels specified by the Food and Drug Administration.

### **The following are not allowed:**

- Carbonated beverages
- Beverages containing additives such as herbal and non-vitamin supplements
- Food colorings and flavors not proven safe by the Food and Drug Administration
- Beverages containing vitamin and/or mineral supplements
- Beverages in glass containers

### **Portion guidelines**

- Beverages, except for water: less than 16 oz.




