INSTRUCTIONS TO BIDDERS

L PREPARING OF BIDS

- A. BIDDER QUALIFICATION FORM qualifies the bidder and the bid and must be completed and submitted as page 1 of the bid.
- 1. PERFORMANCE SECURITY. The form of performance security the bidder will submit, when required to do so, must be furnished. Performance security shall not be submitted with the bid.
- 2. BIDDER CERTIFICATION AND IDENTIFICATION. Bid must contain an original manual signature from an authorized representative. An unsigned bid will be considered non responsive.
- B. INSTRUCTIONS TO BIDDERS define conditions of the bid
- 1. ORDER OF PRECEDENCE. Any inconsistency in this bid shall be resolved by giving precedence in the following order:
 - A. Specifications
 - B. Special Conditions
 - C. Instructions To Bidders
- 2. FOR MWBE designated bids. The SPECIAL CONDITIONS-Minority/Women owned and controlled Business Participation Statement and the MWBE Certification Application MUST be completed and SUBMITTED with the bid if the bidder is not certified by Miami-Dade County Public Schools. Failure to submit the completed application with the bid will be considered non-responsive.
- C. BID PROPOSAL FORM defines requirement of items to be purchased, and must be completed and submitted as page 2 and subsequent pages, if any, of the bid. The bidder should indicate its name in the appropriate space on each page.
- 1. ITEM SPECIFICATION. Specifying a certain brand, make or manufacturer is to denote the quality, type, and standard of the article desired. Articles offered must be new merchandise only, of equal or superior grade. On blank lines provided, the bidder is requested to insert the brand name, manufacturer's number and other information necessary to sufficiently identify article offered. Failure to do so may prevent consideration of the Item. Also, refer to paragraph IX: Packaging.
- 2. PROTEST OF SPECIFICATIONS. Any notice of protest of the specifications contained in an invitation to bid shall be filed in writing with the Associate Superintendent, Bureau of Procurement and Materials Management no later than 48 hours prior to the date and hour specified in the Bidder Qualification Form for receipt of bids. Failure to file a timely notice of protest shall constitute a waiver of proceedings.
- 3. PRICES. Prices are requested in units of quantity specified in the bid specifications. In case of a discrepancy in computing the total amount of bid, UNIT PRICE quoted will govern. All prices bid shall include delivery F.O.B. destination, freight prepaid (bidder pays and bears freight charges. Bidder owns goods in transit and files any claims) and shall include all cartage, drayage, packing, etc., delivered to and unloaded at the receiving station at the site designated in BID PROPOSAL FORMS and there received by the designated agent of the Board.
- 4. TAXES. The Board does not pay Federal Excise and State taxes on direct purchases of tangible personal property. The applicable tax exemption number is shown on the purchase order. This exemption does not apply to purchases of tangible personal property made by contractors who use the tangible personal property in the performance of contracts for the improvement of Board owned real property as defined in Chapter 192 of the Florida Statutes.

IL SUBMITTING OF BIDS

A. BID FORMS AND ENVELOPES. Bids must be submitted on forms furnished by the Board and in scaled envelopes. Envelopes must be clearly marked with bid number, bid title and bid opening.

- B. ERASURES OR CORRECTIONS. When filling out the bid proposal form, bidders are required to use a typewriter or complete bid proposal in ink.
 - 1. Use of penal is prohibited
 - 2. Do not erase or use correction fluid to correct an error
 - 3. All changes must be crossed out and initialed in ink.

Those bids for individual items that do not comply with items 1, 2 and 3 above will be considered non-responsive for that item(s)

- C. PLACE, DATE AND HOUR. Bids shall be submitted by U.S. Mail. Couner/Express Service, or deposited in the BID BOX located in Room 351, 8.00 A.M. to 4:30 P.M., Monday through Friday. SCHOOL BOARD ADMINISTRATION BUILDING, 1450 N.E. Second Avenue, Miami, Florida 33132. Bids received after the date and hour specified in the BIDDER QUALIFICATION FORM will not be considered.
- D. PUBLIC ENTITY CRIMES. Section 287.133(2)(a) Florida Statute. A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017, for CATEGORY TWO for a period of 36 months from the date of being placed on the convicted vendor list.
- E. SUBMITTING A "NO BID." If not submitting a bid at this time, return the form entitled "NOTICE TO PROSPECTIVE BIDDERS." Failure to respond, either by submitting a bid or the "NOTICE TO PROSPECTIVE BIDDERS" form for three consecutive times may result in your company being removed from the School Board's bid list.
- F. AVAILABILITY OF BID INFORMATION. Immediately following the public opening, bids will be read, upon request, and then compiled in a tabular form, a copy of which will be available for examination in Procurement Management.
- Iti. CANCELLATION OF BIDS OR REQUEST FOR PROPOSALS

 An invitation for bids or request for proposals, or other solicitations may be canceled, in whole or in part, as may be specified in the solicitation, when it is in the best interest of the Board. The reasons shall be made a part of the master bid file.
 - A Prior to opening, a solicitation may be canceled in whole or in part, prior to the date and hour specified in the Bidder Qualification Form for receipt of bids, when the Associate Superintendent, Bureau of Procurement and Materials Management, determines in writing that such action is in the best interest of the Board for reasons including, but not limited to:
 - 1. The Board no longer requires the supplies, services, or construction;
 - 2 The Board no longer can reasonably expect to fund the procurement;
 - 3 A review of a valid protest filed by a bidder as may be determined by the administrative staff;
 - 4 Proposed amendments to the solicitation would be of such magnitude that a new solicitation is desirable.
 - B. When a solicitation is canceled prior to opening, notice of cancellation shall be sent to all businesses solicited, via facsimite or mail and bids or proposals returned to the vendor unopened.
 - C. The notice of cancellation shall:

IV. CHANGE OR WITHDRAWAL OF BIDS

- C. FAILURE TO ACCEPT BID AWARD. Bidders who, pnor to the Bid Award by the School Board of Miami-Dade County, Florida, indicate that they are unable to accept the bid award shall either.

V. AWARDS

- A. RESERVATION FOR REJECTION OR AWARD. The Board reserves the right to reject any or all bids, to waive inegularities or technicalises, and to request re-bids. The Board reserves the right to award on an individual item basis, any combination of items, total low bid or, if an alternate bid is accepted, on such terms as are specified for the alternate bid, whichever manner is in the best interest of the Board.
- B. AWARD RECOMMENDATION. Bidder/Proposer information phone lines have been established in Procurement Management. Bidders/proposers may call 995-1375 each Friday to be advised of the recommended bidders or proposers and the time it is contemplated that the recommendation will be made. This information will be provided by school system staff as available. In no case will information as to a recommended bidder/proposer be available later than the Friday preceding the week when the award is scheduled to be made by the School Board or the Superintendent.

Bidders and proposers may file letters of protest no later than 43 hours prior to the Board Meeting for which the award is scheduled to be made. These letters of protest will be reviewed by Staff. Staff will offer the protesting bidder the opportunity for a meeting to discuss the protest. If the bidder is not satisfied with the response to the protest, he/she may request to address the School Board. Alternatively, bidders may invoke the provisions of §120.55? Fla.Stat. Petitions for hearings on protests pursuant to §120.569, Fla. Stat. must be filed in accordance with School Board Rule 6Gx13-8C-1.064. Protests filed later than the date specified herein are deemed waived. This provision supersedes and governs over any conflicting provision in this document.

- C. OFFICIAL AWARD DATE. Awards become official when made unless otherwise specified in the award recommendation.
- D. PURCHASE ORDERS. Purchase orders mailed to successful bidders are the official notification to deliver materials described therein; and the time allowed for delivery begins with the date of the purchase order. In the event that the successful bidder fails to deliver the materials in accordance with the terms and conditions of the bid and purchase order, the bidder shall be considered in default of the contract and subject to the default provisions stated in Instructions to Bidders, Section V. E.
- E. DEFAULT. In the event of defaul, which may include, but is not limited to non-performance and/or poor performance, the awardee shall pay to the Board as liquidated damages an amount equal to 10% of the unit price of the item(s) awarded times the quantity when no purchase order has been issued, 10 percent of the purchase order when a purchase order has been issued or \$100, whichever is greater. - F. - E. PAYMENT FOR SAMPLES. The Board will buy no samples and will assume no cost incidental thereto.
- F. RETURN OF SAMPLES. Samples not destroyed in testing may be claimed by unsuccessful bidders 14 days after bid award date and by successful bidders 14 days after final payment; but the Board will assume no responsibility for samples not claimed within the time specified, and it will pay for no samples damaged in testing.
- G. EVALUATION AND TEST RESULTS. Interested bidders should contact the buyer, prior to the recommendation for award, to determine whether the item(s) submitted complies with the specifications requirements. - B. RECEIVING INSPECTION AND TESTING. Delivered items which do not fulfill all requirements will be rejected. Rejected items shall be removed and replaced promptly by the vendor at no cost to the purchaser.
- C. INVOICES. Each invoice shall be issued by the successful bidder and shall be submitted in DUPLICATE to the Accounts Payable Section, P.O. Box 01-2570, Miami, Florida 33101. To be considered for payment each invoice must show the following information which appears on the Purchase Order:

SPECIAL CONDITIONS

- 1. **PURPOSE:** The purpose of this bid, is to establish a contract, at firm unit prices, for the purchase of estimated requirements for the items listed. The term of the bid shall be for one year from the date of award, and may, by mutual agreement between The School Board of Miami-Dade County, Florida and the awardee, upon final School Board approval, be renewable for **two** additional **one** year periods and, if needed, 90 days beyond the expiration date of the current contract period. The Board, through the Bureau of Procurement and Materials Management, may if considering to renew, request a letter of intent to renew from the awardee, prior to the end of the current contract period. The awardee will be notified when the recommendation has been acted upon by the Board. All prices shall be firm for the term of the contract. The successful vendor(s) agrees to this condition by signing its bid.
- 2. **QUANTITIES:** The quantities or usage shown on the Bid Proposal Form are estimates **only**. No guarantee or warranty is given or implied by the Board, as to the total amount that **may** or **may not** be purchased from the resulting contract(s). These quantities are for bidders' information **only**, to aid in determining whether they will be able to supply the amounts which may be required by the Board.
- 3. **INSURANCE REQUIREMENTS:** Successful vendor(s) are required to have insurance coverage, as specified in the indemnity and insurance form(s), attached hereto and made a part of this bid. The successful vendor(s) must submit completed certificate of insurance form(s), prior to being recommended for award. Failure to submit this form(s), as noted, will result in the vendor(s) not being recommended for the bid award.
- 4. **QUALIFICATIONS OF VENDORS:** Award of this contract will be made to all qualified vendors who meet the applicable criteria, as follows:
 - A. A fully equipped shop, as required in this solicitation, which may be verified by an on-site inspection by M-DCPS personnel.
 - B. The company must have a minimum of four (4) full time employees.
 - C. The company must be able to show a minimum of at least one (1) year of experience in body work repair, refurbishment and painting.
 - D. A facility size of at least 3,750 square feet which will allow for two trucks or buses to be worked on completely inside.
 - E. The facility must have a spray booth large enough to accommodate cars, light and medium trucks, as applicable.
 - F. The facility must provide security in the form of a fenced locked lot, or the inside of a secure building, for no less than two (2) trucks or buses simultaneously.
 - Note: For the purpose of this bid a standard sized vehicle will be defined as a 1990 Ford F800 Flatbed or School Bus Type "D" Class 8.
 - G. Facility must be located within the boundaries of Miami-Dade County, Florida.
- 5. QUALIFYING OF BIDDERS AND ASSIGNMENT OF WORK: These bidders shall be qualified during the bid evaluation process to participate in periodic work assignments that are identified by M-DCPS, on an as needed basis. When such work assignments are identified, the qualified vendors shall receive notification for a quotation/estimate;

review the written specifications regarding the work to be accomplished, inspect the work area, and offer an itemized price, based on the labor rate and the materials to be provided. The vendor offering the lowest fixed price shall be awarded the specific work assignment. The award of a specific work assignment to one (1) vendor does not preclude the ability of the remaining qualified vendors or the awarded vendor, from submitting offers for other work assignments.

Vendors who have been qualified for this bid, but who fail to perform satisfactorily, as determined by M-DCPS personnel, will be dropped from this bid's list of qualified vendors. Selection of vendor to be solicited for job quotation shall be performed by M-DCPS personnel and shall be rotated alphabetically. At least three (3) qualified vendors shall be contacted for quotation for each work assignment. Of the three (3) vendors to be contacted, at least one (1) shall be a minority, if possible.

- 6. **ISSUANCE OF PURCHASE ORDER:** Issuance of a purchase order is contingent upon the receipt of the required insurance documents, within the specified time frame, prior to School Board approval.
- 7. **WARRANTY:** All labor, materials, supplies, paints, parts, etc. supplied by the vendor will be covered by at least a <u>one</u> (1) year unconditional guarantee by the vendor or manufacturer's warranty whichever is greater as follows:
 - A. All collision damage repairs or refurbishment work, including paint, shall be guaranteed for one (1) year against peeling, cracking, fading, or not maintaining OEM quality, chipping, rusting fillers coming loose, and other defects in materials or workmanship. Any such repairs, work, paint or material becoming defective will be corrected to the satisfaction of M-DCPS, at no added cost.
 - B. Refusal of the vendor to honor the above guarantee, upon request, shall be considered as justifiable grounds for default procedures.
- 8. ADDITIONAL CHARGES: There will be no service charges or travel time charges allowed.
- 9. **STANDARDS COMPLIANCE:** All service to be performed under this bid shall be in accordance with all governmental standards, to include, but not limited to, those issued by the Office of Safety and Health Administration (OHSA), The National Institute of Occupational Safety Hazards (NIOSH), and the National Fire Protection Association (NFPA).
- 10. **PARTS LIST(S):** Vendors awarded this contract shall submit to M-DCPS, upon request, all body parts lists and price lists they will be using.
- 11. **LICENSE, PERMITS AND FEES:** The bidder shall obtain and pay for all licenses, permits and inspection fees required for this bid performance and shall comply with all laws, ordinances, regulations and building code requirements applicable to the work contemplated herein. <u>Damages, penalties and/or fines imposed on M-DCPS or the bidder for failure to obtain required licenses or permits, fines shall be borne by the bidder.</u>

- 12. **REPAIR STANDARDS:** As no two vendors will complete their work in the same manner, they may not assess the damage to a vehicle in the same degree, causing their quotation of labor and parts bid to vary. However, the quality of the finished work must equal all of the best standards of the collision repair industry as to preparation of metals for repair, primer and paint standards, and finished quality of the repairs. The successful Vendor will be required to consistently produce the best quality of work using modern facilities, methods, paints and repair techniques performed by individuals knowledgeable and skilled in collision repairs, so the repair(s) confirm with the original body alignment by individuals knowledgeable and skilled in collision repairs, so the repair(s) confirm with the original body alignment and contours, as well as matching existing paint textures and colors. Where collision damaged has caused structural damage or frame/chassis misalignment of any nature, the vendor will be required to align the frame using equipment damage or frame/chassis misalignment of any nature, the vendor will be required to align the frame using equipment currently used in the industry, with trained personnel, to factory new standard frame, chassis alignment. Vendors will be required to have on their premises the proper welding equipment (gas/arc) and spray booth(s). Frame machine(s) and sandblasting ability may be subcontracted out to companies so designated on the bid proposal.
 - 13. **TIME LIMIT FOR MAKING INSPECTION:** Contractor vendors shall make their inspection within 48 hours after being notified of a job to be inspected. Not making an inspection within the required time can cause the job to be awarded to the vendor meeting this requirement at the sole discretion of M-DCPS.
 - 14. **TIME LIMIT FOR RETURNING QUOTATIONS:** Vendors should provide a quotation/estimate within 72 hours of being notified of work to be inspected. Failure of a contract vendor to submit the quotation within 72 hours from notification will be considered "No Quote" and that contract vendor will not be eligible for consideration of award of that repair.

15. QUOTING:

For the purpose of quoting work, the awarded vendors shall submit bid proposals to M-DCPS, itemizing costs, charges and labor rate per hour.

M-DCPS will notify the vendor of each work assignment. The vendor will be given a brief description of the work to be performed and the deadline for submitting the quote. It shall be the responsibility of the vendor to inspect the damages and determine, in detail, all work to be performed before submitting a quotation.

M-DCPS does not require that new materials be used, provided the used materials equal the materials used in the original vehicle, and match the original contours of the vehicle being repaired as to fit and alignment. The vendors should take this into consideration when bidding on this type work. The vendor may bid new materials if they wish, but this decision will be left up to the vendor's professional judgment, noting that all repairs must meet the warranty requirements of these specifications and the standards stated in the repair standard Special Condition #12.

Miami-Dade County Public Schools, at its sole discretion, may provide parts or materials, to be used in the repair of vehicles. Parts that are to be supplied by M-DCPS will be clearly identified at the time of the quote. The vendor will furnish the labor (to be included with his quote) to properly install and finish the items supplied, as well as any other parts, labor, supplies, etc., necessary to produce a finished job.

- The qualified vendor shall state in their quote, in number of days, the reasonable time it will take them to repair the vehicles quoted on "down time". This "down time", in number of days, shall be included in writing as a part of the quotation. In addition to the price quoted M-DCPS will use the vendor's "down time" quote, as well as, the vendor's past history of conforming to quoted "down time", quality of finished work, history of additional costs and additional "down time" and current quantity of vehicles being repaired by the quoting vendor in deciding to award the job. M-DCPS reserves the right to weigh different factors appropriately to the type of vehicle being quoted and its priority of being returned service.
- 17. **ADDITIONAL COST:** The awarded vendor shall notify the using department within 72 hours of the awarded job, of any additional labor, parts cost, or "down time" that may be required to repair previously hidden damages.

INDEMNIFICATION AND INSURANCE

In consideration of this Contract, if awarded, the Vendor agrees without reservation to the indemnification and insurance clauses contained herein. These clauses are attached to and form a part of Bid #035-BB07

INDEMNIFICATION

The Vendor shall hold harmless, indemnify and defend the indemnitees (as hereinafter defined) against any claim, action, loss, damage, injury, liability, cost or expense of whatsoever kind or nature including, but not by way of limitation, attorneys' fees and court costs arising out of bodily injury to persons including death, or damage to tangible property arising out of or incidental to the performance of this Contract (including goods and services provided thereto) by or on behalf of the Vendor, whether or not due to or caused in part by the negligence or other culpability of the indemnitee, excluding only the sole negligence or culpability of the indemnitees: The School Board of Miami-Dade County, Florida and its members, officers and employees.

INSURANCE

Prior to being recommended for award, the Vendor has five business days after notification to submit proof of insurance as required herein. Failure to submit a fully completed certificate of insurance signed by an authorized representative of the insurer providing such insurance coverages may cause the Vendor to be considered non-responsive and not eligible for award of the Contract. The insurance coverages and limits shall meet, at a minimum, the following requirements:

- Garage Liability Insurance in an amount not less than \$1,000,000 combined single limit per occurrence for bodily injury and property damage. Such coverage shall include, but not be limited to Garage Keeper's Liability, for all vehicles owned by the Board in the care of the vendor and coverage will include all liability and not be limited to theft and vandalism.
- 2. Workers' Compensation Insurance for all employees of the Vendor as required by Florida Statutes.

"The School Board of Miami-Dade County, Florida and its members, officers and employees" shall be an additional insured on all liability coverages except Workers' Compensation Insurance.

The insurance coverage required shall include those classifications, as listed in standard liability insurance manuals, which most nearly reflect the operations of the Vendor.

All insurance policies shall be issued by companies with either of the following qualifications:

The company must be (1) authorized by subsisting certificates of authority by the Department of Insurance of the State of Florida or (2) an eligible surplus lines insurer under Florida Statutes. In addition, the insurer must have a Best's Rating of "B+" or better and a Financial Size Category of "IV" or better according to the latest edition of Best's Key Rating Guide, published by A.M. Best Company.

(b) with respect only to the Workers' Compensation insurance, the company must be (1) authorized as a group self-insurer pursuant to Florida Statutes or (2) authorized as a commercial self-insurance fund pursuant to Florida Statutes.

Neither approval nor failure to disapprove the insurance furnished by the Vendor to the School Board shall relieve the Vendor of the Vendor's full responsibility to provide insurance as required by this Contract.

The Vendor shall be responsible for assuring that the insurance remains in force for the duration of the contractual period; including any and all option years that may be granted to the Vendor. The certificate of insurance shall contain the provision that the School Board be given no less than thirty (30) days written notice of cancellation. If the insurance is scheduled to expire during the contractual period, the Vendor shall be responsible for submitting new or renewed certificates of insurance to the School Board at a minimum of fifteen (15) calendar days in advance of such expiration.
