STATUS OF ADDENDUM

To date, this is the first (1st) addendum that has been issued for Request for Proposals 003-LL10, Consulting Services, Employee Benefit Programs.

ADDITIONAL INFORMATION REQUESTED

The following is provided in response to proposers' specific requests for additional information:

1. Q: Under the Minimum Requirements, the School Board lists the following requirement:

Experience with Florida Public School Programs: The lead consultant to be assigned to the Board's account must have substantial first-hand experience in providing consulting services to one Florida School Board regarding their medical plan. It is anticipated that the lead consultant will identify a specific project team for this contract, with members of the project team under the direction of the lead consultant.

While we do not have direct health experience with primary and secondary public school programs in the State of Florida, we do have experience working with post-secondary institutions regarding health plan consulting. Would the School Board be willing to substitute this kind of experience in place of primary/secondary public school program experience?

A: No, the Minimum Qualifications contained in the RFP were approved by the School Board at the Board meeting of October 13, 2010.

2. Q: In section I Minimum Qualifications Item B states:

No Sale of Insurance: The consulting team shall not be engaged in any way in the sale or placement of insurance coverages as an agent or broker. In addition, there will be no commissions paid on the benefit program. If the proposing firm has a brokerage division, proposers should describe how conflicts of interest are avoided.

Will the minimum qualifications be reconsidered to allow for members of the consulting team to act as brokers?

- A: No, the Minimum Qualifications contained in the RFP were approved by the School Board at the Board meeting of October 13, 2010.
- 3. Q: Is there a point system that the board will be using to score the proposals submitted? If so, please clarify.
 - A: There is no point system. The criteria listed in the RFP under the Proposal Evaluation on Section I, page 3 is the criteria which the Board will consider in its evaluation.
- 4: Q: Would our consulting services be extended to your union groups as well? If so, please provide further information regarding the union contracts; how many unions, when do their collective bargaining agreements terminate and how many employees are unionized.
 - A: No, consulting services will not be extended to union groups.
- 5. Q: Please confirm the number of members that reside outside the state of Florida and in which states they reside.
 - A: This information is not readily available at the time of this addendum. However, it is an insignificant number of employees on leave of absence or retirees under 20.
- 6. Q: Please confirm the total amount of consulting fees paid to Deloitte Consulting over the last three years.
 - A: Please see the attached spreadsheets outlining the total amount of consulting fees paid to Deloitte Consulting.
- 7. Q: Please confirm the breakdown of the total hours billed by Deloitte Consulting for Lead Consultant, Senior Consultant, Consultant, Fellow Actuary, Associate Actuary, Medical Consultant, Legal Consultant and Clerical over the last three years.
