Addendum #1**

**Question #1:**

Clarification regarding the PROFESSIONAL LIABILITY, my insurance agent cannot find it for PAINTER.

**ANSWER:**

Clarification has been given to us that Professional Liability Insurance pertains to a different field. All other insurance requirement must be met.

**Question #2**

Would be necessary to buy all these insurance before knowing if you are going to be awarded?

**ANSWER:**

Yes.

**Question #3**

Clarification - Page 25 says 3 years of experience in general painting, my qualifier has 21 years of experience in general painting in USA, required course to receive the license, a title of engineer from the University of Havana and special training in painting from technical schools in Cuba. Of course we have the painting License from MDC dated December 2014.

**ANSWER:**

As clarified in the Pre-Bid meeting, the MINIMUM of three years experience requirement refers to the qualifier being properly licensed, for painting, or in a General Contractor capacity, for a MINIMUM of three years.

**Question #4**

The paragraph number 5 in the page 29 you clarified that it doesn't matter when the corporation was register as long that has the proper qualifier.

**ANSWER:**

The requirement for years of experience refers to the qualifier being properly licensed for a MINIMUM of three years, not the company.

**Question #5**

The General Liability and auto Insurance is high for small companies. We need to submit the insurance in this range as part of the package or just when we have the work. Please clarify.

**Answer:**

At the time of submission of bid proposal, you must meet the insurance requirements as listed in the bid. The only insurance listed that does not apply is the Professional Liability insurance which has been stated in question #1.
