Addendum #1, ITB 17-010-HR Hood Cleaning Services

The following Price Adjustment clause has been added to this ITB:

PRICE ADJUSTMENT

It is expected that the prices submitted shall remain firm for the entire contract and extension period. Although pricing is fixed for the term period(s), M-DCPS encourages the awardee(s) to offer any reduction in fees throughout the term of the contract, including the initial term period. However, fluctuating market conditions may affect the ability of awarded bidder(s) to maintain the original bid prices during the extension period. Therefore the awarded Bidder(s) may request a price adjustment based on verifiable changes in the market to be valid for the upcoming contract extension period. This price adjustment is subject to approval by M-DCPS.

All requests for price adjustments must be submitted in writing to Procurement Management Services, with substantial documentation, including but not limited to, applicable market indexes for the product(s) affected, letters from the manufacturer/producer of the product(s), Producer Price Indexes (PPI) published by the U.S. Department of Labor, and any other documentation supporting a request for price adjustment. The price adjustment shall not exceed the producer price index as reported by the Department of Labor.

M-DCPS will review all requests for price adjustments, and reserves the right to reject or to modify any and all requests as deemed to be in the best interest of M-DCPS with appropriate documentation provided to the awarded bidder(s). If mutually agreed upon, the price adjustment(s) shall be valid for the next contract and/or extension period unless the adjustment period is otherwise stated and approved by Procurement Management Services

M-DCPS Procurement Management Services may request the bidder to adjust their prices at any time during the award and/or extension period, for any reason with valid documentation (i.e. due to fluctuating market conditions in the Producer Price Index or other market indices, etc.), which produces conditions deemed favorable and to be in the best interest of M-DCPS.

The following list addresses the questions received regarding the above-referenced solicitation:

1. I just wanted to confirm that per section 2.7 pricing #A "the awarded bidder shall provide a flat price for a hood system for elementary middle senior High and other special Centers. Some sites do have more than one Hood system usually the senior highs" If you look at section 3.1 price proposal sheet item #1 under "unit", it states "per site". I just want to clarify that we are pricing per standard Hood system and not at an overall price per site. I had the same question come up when I bid before and I believe the response was an amendment was written and that verbiage was changed to per hood.

Answer: Yes, as discussed at the pre-bid meeting, bidders will now be required to submit pricing "PER HOOD SYSTEM" and not per school site. We are aware that the schools have more than one hood system and this would be fair for all vendors bidding.
