QUESTIONS AND ANSWERS:

Q1: As a non-minority male business owner are we excluded from doing business with MDCPS?

A1: This is a sheltered market bid only for certified firms. Only firms certified by the M-DCPS Office of Economic Opportunity may participate in this bid.

Q2: Also, some of the stipulations on the contract are not industry standards. Two month warranty is double typical warranty periods. Power Equipment Warranty is not specific to what type of equipment. Most handheld brands only offer 2 year factory warranty. Also pressure washers have 3 month warranty on most pumps I have never heard of 7 year warranty. If you could please let me know.

A2: This is not a question.

Q3: If anyone has a question for example, if your certification status is still valid?

Q4: What would the vendor do if there is a similar item to a discontinued item on the bid?

A4: The vendor should submit the comparable item along with a letter from manufacturer stating the item is no longer manufactured. The submittal will be reviewed once the bid has opened.

Q5: Once the bid is open, if the manufacturer do not offer the whole warranty is a third-party warranty service the responsibility of the vendor?

A5: Yes. As long as the specifications/warranties are met, it can be a third-party warranty.
