## ITB-20-020-HR MILK AND DAIRY PRODUCTS

#### **ADDENDUM NO. 1**

The following changes, additions, clarifications, and/or deletions amend the ITB document of the above captioned solicitation and shall become an integral part of the Contract Documents.

<u>Section 6.2, Bid Item Specifications (E & F):</u> has been removed from the solicitation. The Department of Food & Nutrition receives the raw price adjustments report on a monthly basis, which is the information that is needed.

Section 6.20, Price Adjustments, A: Raw Milk Price Calculation, has been replaced with: "All raw milk pricing for milk products shall be predicated on the Class I Price for Milk at 3.5% milk fat (per cwt.) as established and published in the United States Department of Agriculture (USDA) "Announcement of Advanced Class Prices" (Federal Order No. 6) for applicable geographical zone, plus (+) the over order premium as reflected in the "announced price" for Class I Milk per cwt., Zone 5, as published by the areas two major Dairy Cooperatives, Southeast Milk, Inc., and Dairy Farmers of America – Southeast Council. Price adjustments shall be made on a MONTHLY basis. The bid price adjustment shall be made based on the last published FMO, Federal Milk Order, for their region."

## **QUESTIONS AND ANSWERS:**

- Q1: What method of electronic ordering do you intend to use? FTP from the district office? On-line orders from individual schools?
- A1: The awarded vendor must have the ability to receive, process and consolidate electronic orders weekly both by individual sites and/or central office. The electronic ordering system must have reporting and tracking capabilities.
- **Q2:** What month should the raw milk price be based on?
- A2: Our understanding is that the raw milk price should be based on the month that the solicitation was published, which was 1/25/2021. Therefore, raw milk price should be based on the January 2021 raw milk price.
- Q3: Would you authorize milk price adjustments based on butterfat and skim, rather than .00054 for change in hundredweight which is based on 3.5% butterfat? Attached are examples from Broward, Hillsborough, and Orange County for your reference. There are several others as well and if you'd like their bid pages they can be provided.
- A3: The raw milk price calculation as outlined in the scope of services for this ITB is what the District will adhere to.
- **Q4:** Are you presently serving the strawberry half pint? If so, what is the volume # of locations to be served?
- A4: No, we are currently not serving strawberry half pint milk. Service will be required for all M-DCPS school locations.

**Q5:** What is the delivery frequency?

A5: Delivery will be required every day at some sites; twice daily or every other day at other sites.

**Q6:** Are any equipment required?

A6: All equipment to store and offer milk and dairy items to students at sites. Trucks that are delivering milk have to be refrigerated trucks, and drivers must have equipment needed to transport and deliver milk and dairy product items.
