Addendum #2, Purchase of Original Equipment Manufacturers and Aftermarket Parts

- I have a copy of your bid for OEM & aftermarket parts. For the price list, how can I get my company added so I can offer a discount?
 Answer: Please submit the information to Procurement and the department will be notified of your request to add your company.
- Page 8 Status Verification; Sub Para. 2 does this refer only to the use of subcontractors used in the execution of the bid? Answer: Yes, that is correct.
- Page 9/10 Local And State Vendor Preference; sub Para.XXV1 Section A and Page 15 Section 7; Scope of Work; we are located in Collier County – will this disqualify us from entering a bid?
 Answer: No, this will not disqualify you from entering a bid.
- It would help us tremendously if you were able to advise us as to how many and what sort of Mercedes Benz vehicles you have in your fleet.
 Answer: We currently have a few freightliner vehicles with Mercedes Benz engines.
- Mercedes Benz USA does not publish price lists; the information is only available online. Would it be acceptable to give you access to this list rather than try to download over 600,000 lines of price information many of which would be irrelevant? Answer: Yes, showing manufacturer's price list and cost.
- Thank you for the invitation after printing the 30 pages I have yet to see what aftermarket parts you are requesting can you please tell me the page that's on?
 Answer: Please download the spreadsheet that is also available on the website.
 All solicitations can be found at http://procurement.dadeschools.net as well as on Bidsync and Demandstar.
- Does MDCPS ever sent RFQ's? All I see are large bids.
 Answer: Yes, RFQ's are posted on our procurement website at http://procurement.dadeschools.net.
- For items #1-72 on pages 37-40 of the proposed discount sheets, there are Aftermarket Distributors listed not Aftermarket *Manufacturers*. Aftermarket distributors, like ourselves, supply many products from many different manufacturers. We are not listed within items #1-72, where should we submit our discount?
 Answer: Provide access to on-line pricing showing manufacturer's price list and cost.
- As stated in the pre-bid meeting, most manufacturers no longer provide price sheets. Please confirm that our price lists are acceptable for bid submission.
 Answer: Provide access to on-line pricing showing manufacturer's price list and cost.
- 10. As per our discussion this morning, I am seeking clarification on the requirement for price lists. Several of our vendors no longer issue price lists, all pricing and ordering is done online. At least one of our vendors does not offer list pricing, they only offer cost

pricing it is up to the dealer to determine the list price. Not sure how we would handle these items, we are talking tens of thousand of part numbers that would have to be manually entered on a spreadsheet or word document to meet your requirements.

On the list of manufacturers who you are seeking parts for, I see many dealers listed, see below please for a sample. A dealer is not a brand per se, please clarify how we are supposed to bid these items.
