**PURPOSE:** The purpose of this bid is to establish a contract, at firm unit prices, for the purchase of fertilizer for Maintenance Materials Management stock.

**PURPOSE:** The purpose of this bid is to establish a contract, at firm unit prices, for the purchase of special mix fertilizer for Maintenance Materials Management stock.

**AWARD:** Award of this bid may be made to a primary vendor and two (2) alternate vendors, who offer the lowest price for each item meeting specifications as described in this bid. The awarded vendors shall submit quotes when requested every three (3) months. The initial prices submitted on this bid shall be used to determine the low bidder and remain firm and be effective for the first three-month term period following award. If the primary awardee fails to perform under the terms and conditions of the contract, the first alternate will be requested to deliver goods described herein. Any vendor not responding to the request for quote (RFQ) by the required date will not be considered for award for that three-month period. The low bidder meeting specifications will be the primary vendor for each subsequent three-month period and the second and third low bidders will become the alternates. Prices shall remain firm and fixed for that period.
