QUESTIONS AND ANSWERS:

Q1: Request for extension time for submittal of package for above Term-Bid.

- A1: The deadline for the referenced ITB has been extended to to Thursday, October 19, 2023 at 1:00 p.m. Eastern Time (ET) via DemandStar.
- Q2: Good day. Please, we are contractors in Miami Dade that we are interested in ITB-22-019-MF project. However, we see that to participate in this project we need to prequalify with Miami Dade School County Public Schools and they are now requiring a State License such as a FL Underground Utility license.

We currently have a Paving Engineering Contracting License. We are Miami Dade SBE and we work all over Dade completing government projects like Public Works, Water and Sewer, and Parks and Recreation. Is there any way we can participate in this project without a State Level License? We can pull permits for all paving projects throughout Miami- Dade County and have a great record with the county. We hope to be able to bid without the stipulation of prequalifying with a state license. Please advise. Thank you.

A2: The purpose of this ITB is to establish a pool of pre-approved vendors based on all the requirements listed on Attachment 12 – Submitted Bid Qualification Form pursuant to revise Section 6.1.6 noted below. Awarded vendors who are pre-qualified will be able to participate on the projects requiring pre-qualification.

REVISED SECTION 6.1.6

6.1.6 - CONTRACTOR PRE-QUALIFICATION

Awarded contractors will be permitted to perform work classified as general maintenance and repair under the authority of the Annual Maintenance Permit. However, some work generally accomplished under the Annual Maintenance Permit may require the Vendor to be pre-qualified. Only contractors who have successfully been prequalified pursuant to State Requirements for Educational Facilities (SREF [2014]), Chapter 6-2, Section 4.1(8), Florida Statute 1013.47(2), and M-DCPS Board Policy 6334, will be permitted to perform such work. Additionally, only pre-qualified contractors can perform work classified as construction and any work requiring a separate permit from the M-DCPS Building Department. Any contractor who does not possess a Contractor Prequalification Certificate shall be prohibited from receiving an award for work that requires such certification until such time that the vendor obtains this certification.
