Justification: It is considered to be in the best interest of the Board to extend this contract with the six vendors who have indicated a willingness to provide charter services, by letter, on file, at the adjusted prices for another year. The terms and conditions of the contract provide for a 5% increase during an extension period. The price of fuel, both gasoline and diesel, has escalated to record levels in the 18 months since bid opening. In the past 12 months, the OPIS average rack price for one gallon of unleaded gasoline has posted a 23% increase, from 1.673 in August 2005, to 2.175 in May 2006. Similarly, diesel has risen 22%, from 1.717 in August 2005, to 2.199 in May 2006. The vendors electing to extend the contract have provided satisfactory service during the past contract period.
