Purpose of Contract: The purpose of this contract is to provide sports-drink vending machines and corporate sponsorship for the enhancement of the Greater Miami Athletic Conference (GMAC) and the athletic program of The School Board of Miami-Dade County, Florida, for the Department of Athletics/Activities.

Original Award Date: June 16, 2004

Terms of Contract Award and Extension: Two years, with an option to extend for three (3) additional one-year periods and, if needed, an additional ninety (90) days beyond the expiration date.

Previous Extension Date: June 2006

Previous Extension Amount: N/A

Vendors Recommended for Contract Extension: One (1)

The Pepsi Bottling Group

Justification: It is considered to be in the best interest of the District to extend this contract for an additional six (6) month period, to maintain the highest negotiated revenue. Staff has indicated that the vendor's performance has been satisfactory. This six-month extension will complete the third year of the contract. In June 2006, a six month extension was processed through December 29, 2006; however, it is necessary to extend the contract through June 29, 2007, in order for the issuance and award of a new Request For Proposals. The awardee has agreed to extend for an additional six month period, by letter, on file.

Purpose of Contract: The purpose of this contract is to provide for the purchase of auction services to dispose of excess and/or obsolete Miami-Dade County Public Schools property and equipment.

Original Award Date: June 19, 2002

Terms of Contract Award and Extension: Eighteen months, with an option to extend for three (3) additional eighteen-month periods and, if needed, an additional ninety (90) days beyond the expiration date.

Previous Extension Date: January 2004 and July 2005

Previous Extension Amount: N/A

Vendors Recommended for Contract Extension: One (1)

Fisher Auction Company, Inc.

Justification: It is considered to be in the best interest of the District to extend this contract for an additional eighteen (18) month period, to benefit from continuity of service and the most favorable fixed buyer premium. This bid does not utilize any District funds to pay for Auctioneer Services, but instead charges a buyer premium to the bidder at the time of purchase, which enables M-DCPS to realize the full bid price of the auctioned item. The originator has indicated that the vendor's performance has been satisfactory and recommends extension. This is the third extension and final eighteen (18) months on this contract. The awardee has agreed to extend for an additional eighteen (18) month period, by letter, on file.
