CONTRACT EXTENSION SUMMARY

Contract No.: 097-EE06

Contract Title: IRRIGATION SYSTEM REPLACEMENT AND GENERAL REPAIRS

Extension Award Amount: \$48,140

Extension Period: August 17, 2008 – November 16, 2008

Purpose of Contract: The purpose of this contract is to pre-qualify vendors to furnish all labor, supervision, equipment and materials necessary, to perform replacement and general repairs of irrigation systems at Miami-Dade County Public Schools facilities, for Maintenance Operations.

Original Award Period: August 17, 2005 – August 16, 2006

Terms of Contract Award and Extension: One (1) year, with an option to extend for two (2) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date.

Previous Extension Period: August 17, 2007 – August 16, 2008

Previous Extension Amount: \$350,000

Vendors Recommended for Contract Extension: Three (3)

Kendall Sprinkler Service, Inc.
Superior Landscaping and Lawn Service, Inc.
Vila and Son Landscaping

Justification: It is considered to be in the best interest of the District to extend this contract for an additional ninety (90) day period, to provide continuity of service. Staff has indicated satisfactory performance from the vendors and recommends extension. This is the final extension of the contract. The awardees have agreed to extend for an additional ninety (90) day period, by letter, on file.
