Purpose of Contract:

The purpose of this contract is to supply and install, at firm unit prices, quantities, as may be required, of reinforced concrete and related services, for Maintenance Operations. The awarded vendors are responsible to provide services as primary and alternate contractors.

Original Award Period:

April 17, 2006 – April 16, 2007

Terms of Contract Award and Extension:

One (1) year, with an option to extend for three (3)

additional one (1) year periods and, if needed, an additional

ninety (90) days beyond the expiration date.

Previous Extension Period: April 17, 2008 – April 16, 2009

Previous Extension Amount: \$821,810

Vendors Recommended for Contract Extension: Two (2)

Inland Engineering Contractors, Inc. (Primary)

Russell Building Movers, Inc. (Alternate)

Justification: It is considered to be in the best interest of the District to extend this contract for an additional one (1) year period, to benefit from fixed prices. Subsequent to the initial award of this contract, prices for concrete have increased by 9% and 54% for Florida Department of Transportation (DOT) lime-rock base. Staff has indicated satisfactory performance from the vendors and recommends extension. This is the third extension of the contract. The awardees have agreed to extend for the final one (1) year period, by letter, on file.
