

Contract Title: BLEACHERS: REPAIR AND REPLACE

Recommended Extension Award Amount: \$28,907

Purpose of Contract: The purpose of this contract is to repair and replace bleacher systems. The awarded pool of vendors is responsible to service this contract, through a competitive request for quotation process, for projects above the quotation threshold. Contractors agree to furnish all labor, supervision, equipment, materials and items and/or work incidental to providing bleacher-system repairs or replacement work, for Maintenance Operations.

Terms of Contract Award and Extension: One (1) year, with an option to extend for three (3) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date.
