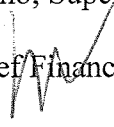


Purpose of Contract: The purpose of this contract is to provide before and/or after-school, on-site childcare services for elementary and exceptional school children centers, for School Operations, Adult Education and Community Education.

Terms of Contract Award and Extension: Three (3) consecutive calendar school year periods, with an option to extend for two (2) additional calendar school year periods and, if needed, an additional ninety (90) days beyond the expiration date.
