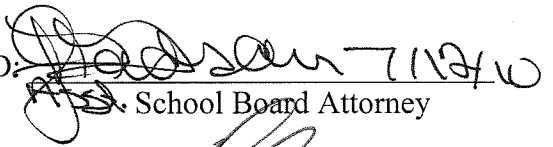

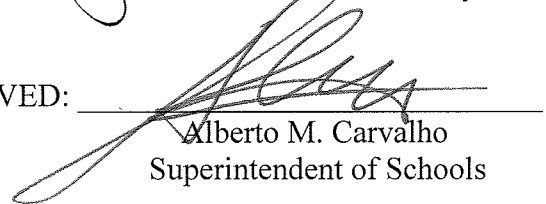

**CONTRACT EXTENSION SUMMARY**

Contract No.: 081-HH11

Contract Title: TWO-WAY RADIOS & ACCESSORIES, CATALOG DISCOUNT
