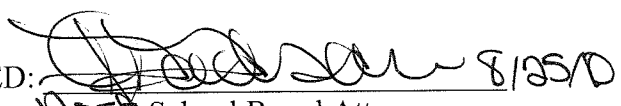


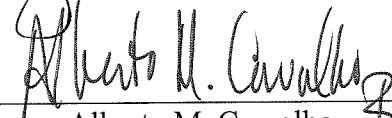
SUBJECT: SUPERINTENDENT'S EXTENSION OF CONTRACTS

**CONTRACT EXTENSION SUMMARY**

Contract No.: 068-GG06

Contract Title: TREE, PALM AND SHRUB PRUNING/REMOVAL

Recommended Extension Award Amount: \$120,000

Current Extension Amount: \$177,450

Original Award Amount: \$2,000,000

Recommended Extension Period: September 5, 2010 – September 4, 2011

Purpose of Contract: The purpose of this contract is to pre-approve vendors for tree trimming, palm and shrub removal, for Maintenance Operations.

Terms of Contract Award and Extension: One (1) year, with an option to extend for three (3) additional one (1) year periods and, if needed, an additional ninety (90) days beyond the expiration date.
