



Purpose of Contract: The purpose of this contract is to purchase automotive repair services, and specialized repairs, for the Department of Transportation, Vehicle Maintenance.

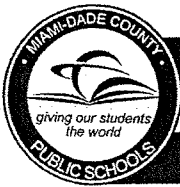

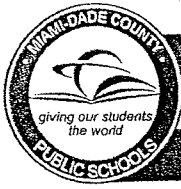
