Purpose of Contract: The purpose of this contract is to purchase, at firm unit prices, unframed marker boards, for Maintenance Materials Management stock.

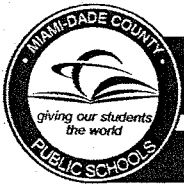
